
**AMENDED AND RESTATED  
CERTIFICATE OF FORMATION  
OF  
BORAL STONE PRODUCTS LLC**

This Amended and Restated Certificate of Formation of Boral Stone Products LLC (the "Company") is being executed and filed by the undersigned authorized person for the purpose of amending and restating the Company's Certificate of Formation, as amended, under the Delaware Limited Liability Company Act (6 Del. C. § 18-101, *et seq.*).

The Company's original Certificate of Formation was filed on July 5, 2006 under the name Owens Corning Cultured Stone, LLC. The original Certificate of Formation was amended on August 3, 2007 to change the name of the Company to Owens Corning Masonry Products, LLC. The original Certificate of Formation was further amended on January 4, 2011 to change the name of the Company to Boral Stone Products LLC. This Amended and Restated Certificate of Formation is being filed pursuant to Sections 18-202 and 18-208 of the Delaware Limited Liability Company Act.

1. The name of the limited liability company is Westlake Royal Stone LLC.
2. The Company's registered office in the State of Delaware is located at Corporation Trust Center, 1209 Orange Street, Wilmington, Delaware 19801, County of New Castle. The registered agent of the Company for service of process at such address is The Corporation Trust Company.
