TRADEMARK ASSIGNMENT

Google authorizes and requests the applicable government authorities to record OUC as the owner of the Open Source Trademarks and to issue any and all registrations, including renewals thereof, to and in the name of OUC.

From time to time, promptly following receipt of a written request from OUC, and without further consideration, Google will do, execute, acknowledge and deliver, or will cause to be done, executed, acknowledged and delivered, all and every such further acts, conveyances, transfers, assignments, oaths, exhibits, declarations, powers of attorney, other documents and assurances as OUC may reasonably require or that OUC deems advisable to (i) effect, evidence, perfect or record the assignment of the Open Source Trademarks; (ii) prepare and prosecute any application, renewal, extension or equivalent to the foregoing for any of the Open Source Trademarks; or (iii) bring or defend any interference, invalidation, cancellation, opposition, infringement, Uniform Domain-Name Dispute-Resolution Policy (or equivalent action) or other proceeding that may arise in connection with the Open Source Trademarks, including testifying as to any facts relating to the Open Source Trademarks.

Google agrees to continue to manage and provide advice regarding the technical aspects of the Istio, Gerrit, and Angular open source projects pursuant to the terms and conditions of this Assignment and any trademark guidelines developed for the Open Source Trademarks by OUC. Google's technical leadership of these open source projects will also continue to participate in any trademark guideline development for their respective project trademarks by contributing technical know-how to the OUC trademark committee.

This Assignment shall be governed by and construed under and in accordance with the Law of the State of California without regard to any contrary result otherwise required under applicable conflict or choice of law rules.
