**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of December 1, 2021 (“Release”), is made by MUZINICH BDC, INC. (“Secured Party”) in favor of RECREATIONAL PRODUCTS CONSOLIDATION COMPANY, LLC, a Delaware limited liability company (the “Borrower”) and AQUA-LEISURE RECREATION, LLC, a Delaware limited liability company (“Aqua”, and together with the Borrower, each a “Grantor” and collectively the “Grantors”).

**WHEREAS**, pursuant to that certain Security and Pledge Agreement dated as of January 8, 2021 (as amended, restated, supplemented or modified from time to time, the “Security Agreement”) by and among the Grantors, Secured Party, and others party thereto, and the Intellectual Property Security Agreement dated as of January 8, 2021 by and among the Grantors and Secured Party (“IP Security Agreement”), Grantors granted to the Secured Party a continuing security interest in all of each Grantor’s right, title and interest in, to and under the Trademark Collateral, Patent Collateral, and Copyright Collateral, including the foregoing referred to in Schedule 1 attached hereto (collectively, “IP Collateral”);

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on March 3, 2021 at Reel 7208 Frame 0895 (trademarks) and on March 3, 2021 at Reel 055476 Frame 0129 (patents), submitted to the United States Copyright Office (“USCO”) on or about January 8, 2021 and pending recordation, recorded at the Canadian Intellectual Property Office (“CIPO”) on May 18, 2021 at File No. 1215402 (trademarks) and on July 8, 2021 at Reg. No. 05826809 (patents), and submitted to the CIPO on or about September 14, 2021 and pending recordation (designs).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantors agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement.

**SECTION 2. Termination and Release.** Secured Party, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in all of each Grantor’s right, title and interest in, to and under the IP Collateral, including, but not limited to, the foregoing referred to in Schedule 1 attached hereto, granted pursuant to the Security Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO, USCO, and CIPO at Grantors’ expense.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Second Lien Pledge and Security Agreement dated as of December 1, 2021 (as amended, restated, supplemented or modified from time to time) by and among the Grantors, Muzinich BDC, Inc., as Administrative Agent and Collateral Agent thereto, and others party thereto.
