**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 1, 2021 (“Release”), is made by Fifth Third Bank, National Association, as Administrative Agent (“Administrative Agent”) in favor of Fidelity Engineering, LLC, a Maryland limited liability company (“Debtor”).

WHEREAS, pursuant to that certain Security Agreement dated as of June 14, 2018 (as amended, modified, extended or restated from time to time, the “Security Agreement”) by and among the Debtor, Administrative Agent, and others party thereto, Debtor granted to the Administrative Agent, for the benefit of the Secured Parties, a Lien on and security interest in, and right to set-off against, all right, title and interest of Debtor in and to all trademarks and all goodwill of the business connected therewith or represented thereby, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Debtor executed and delivered to Administrative Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on June 15, 2018 at Reel 6354 Frame 0111 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Debtor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Lien on and security interest in, and right to set-off against, all right, title and interest of Debtor in and to all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Debtor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
