#### RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 3<sup>RD</sup> day of December 2021, by JPMorgan Chase Bank, N.A., in its capacity as the administrative agent (the "Administrative Agent") for the Lenders (as defined in the Security Agreement, as defined below), in favor of Pango, Inc., a Delaware corporation, Intersections Inc., a Delaware corporation, iSubscribed Inc., a Delaware corporation, and IISI Insurance Services Inc., an Illinois corporation (each a "Grantor", and collectively, the "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 30, 2020 made by the Grantors in favor of the Administrative Agent (the "Security Agreement"), which was recorded with the United States Patent and Trademark Office on July 2, 2020, at Reel 6988, Frame 0916, a security interest was granted by the Grantors to the Administrative Agent in the Trademark Collateral (as defined in the Security Agreement), including the United States trademark registrations and trademark applications set forth in Schedule A hereto;

WHEREAS, the Administrative Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in all Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Agent hereby states as follows:

- 1. <u>Release of Security Interest</u>. The Administrative Agent, on its and the Lenders' behalf, hereby terminates the Security Agreement and terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by each Grantor in favor of the Administrative Agent in and to the Trademark Collateral, and re-assigns to Grantor, any right, title or interest the Administrative Agent or any Lender may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby.
- 3. <u>Recordation of Release</u>. The Administrative Agent understands and agrees that this Release may be recorded by or for each Grantor, or its successors or assigns, with the United States Patent and Trademark Office.
- 4. <u>Governing Law</u>. This Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, excluding conflict of laws principles that would cause the application of laws of any other jurisdiction.
