**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of December 31, 2021, by **DEUTSCHE BANK AG NEW YORK BRANCH**, a German banking corporation (in such capacity, together with its successors and assigns in such capacity, “Administrative Agent”) in favor of **THE TOPPS COMPANY, INC.**, a Delaware corporation with an address at One Whitehall Street, New York, New York 10004 and **TOPPS PROPERTIES, INC.**, a Delaware corporation with an address at One Whitehall Street, New York, New York 10004 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated October 2, 2013 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on October 2, 2013 at the United States Patent and Trademark Office at Reel 5123, Frame 0140.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantors granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of each such Grantor’s right, title and interest in any and all of the following (collectively, the “Trademark Collateral”):

(a) registered Trademarks and Trademark applications of each such Grantor, including those set forth in **Schedule A** attached hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by the foregoing;

(d) any and all claims for damages and injunctive relief for past, present and future infringement, misappropriation, violation or misuse with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(e) any and all Proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, all products of, and supporting obligations relating to, any and all of the Trademark Collateral of or arising from any of the foregoing.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors any interest in such intellectual property.
