INTELLECTUAL PROPERTY RELEASE AND TERMINATION

THIS INTELLECTUAL PROPERTY RELEASE AND TERMINATION is made as of January 18, 2022, by WILMINGTON TRUST, NATIONAL ASSOCIATION, solely in its capacity as notes collateral agent (in such capacity, “Collateral Agent”) for the Secured Parties. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the IP Security Agreement (as defined below).

WITNESSETH:

WHEREAS, THE DUN & BRADSTREET CORPORATION, a Delaware corporation, AVENTION, INC., a Delaware corporation, DUN & BRADSTREET EMERGING BUSINESSES CORP., a Delaware corporation, DUN & BRADSTREET INTERNATIONAL, LTD., a Delaware corporation, DUN & BRADSTREET NETPROSPEX, INC., a Delaware corporation, DUN & BRADSTREET, INC., a Delaware corporation, HOOVER’S INC., a Delaware corporation and LATTICE ENGINES, INC., a Delaware Corporation (each, a “Grantor” and, collectively, the “Grantors”) and Collateral Agent are parties to that certain Security Agreement, dated as of February 8, 2019 (the “Security Agreement”), pursuant to which each Grantor and Collateral Agent executed that certain Trademark Security Agreement dated as of February 8, 2019 (“TM Security Agreement – 1”), that certain Trademark Security Agreement dated as of May 4, 2021 (“TM Security Agreement – 2”), that certain Trademark Security Agreement dated as of August 4, 2020 (“TM Security Agreement – 3”) that certain Trademark Security Agreement dated as of May 21, 2021 (“TM Security Agreement – 4”) or that certain Trademark Security Agreement dated as of October 29, 2019 (“TM Security Agreement – 5” together with TM Security Agreement – 1, TM Security Agreement – 2 and TM Security Agreement – 3, the “IP Security Agreement”);

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, each Grantor granted a security interest to Collateral Agent in certain Intellectual Property Collateral as security for certain obligations owing by the Grantors to Collateral Agent, including the Trademarks set forth on Schedule A hereto;

WHEREAS, TM Security Agreement – 1 was recorded by the Trademark Division of the United States Patent and Trademark Office on February 12, 2019, at Reel 6558 Frame 0304;

WHEREAS, TM Security Agreement – 2 was recorded with the Trademark Division of the United States Patent and Trademark Office on May 4, 2021, at Reel 7281 Frame 0012;

WHEREAS, TM Security Agreement – 3 was recorded with the Trademark Division of the United States Patent and Trademark Office on August 11, 2020 at Reel 7019 Frame 0297;

WHEREAS, TM Security Agreement – 4 was recorded with the Trademark Division of the United States Patent and Trademark Office on May 26, 2020 at Reel 6946 Frame 0055;

WHEREAS, TM Security Agreement – 5 was recorded with the Trademark Division of the United States Patent and Trademark Office on January 23, 2019 at Reel 6792 Frame 0604;

WHEREAS, the Grantors have requested that Collateral Agent release its security interest in the Intellectual Property Collateral and reassign any and all rights in the same to each Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases its security interest, granted pursuant to the Security Agreement and the IP Security Agreement, in all of each Grantor's right, title and interest in and to the Intellectual Property Collateral, including but not limited to the following:

the registered Trademarks (as defined in the Security Agreement) and Trademarks for which applications are pending in the United States Patent and Trademark Office set forth in Schedule A hereto.

2. Collateral Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Intellectual Property Collateral.



Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents prepared by or on behalf of the Grantor and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby, at Grantor's sole cost and expense.

4. Wilmington Trust, National Association is entering this Agreement solely in its capacity as "Notes Collateral Agent" under the Indenture (as defined in the IP Security Agreement), and in acting hereunder, shall be entitled to all the rights, privileges, immunities and indemnities granted to the "Notes Collateral Agent" in the Indenture as if such rights, privileges, immunities and indemnities were set forth herein.


