## **RELEASE OF INTEREST IN TRADEMARKS**

THIS RELEASE OF INTEREST IN TRADEMARKS (this "Release"), dated as of February 25, 2022, is made by FIFTH THIRD BANK, NATIONAL ASSOCIATION (f/k/a Fifth Third Bank), as Administrative Agent ("Administrative Agent") for the holders of the Secured Obligations, and is as follows:

WHEREAS, Administrative Agent and VOLLEY MEDIA, LLC, a Delaware limited liability company ("Obligor"), among others, are parties to that certain Security and Pledge Agreement dated as of May 9, 2018 (the "Security Agreement"), pursuant to which, among other things, Obligor granted a security interest in the trademarks and trademark applications described on Schedule I attached hereto and incorporated herein by reference (collectively, the "Trademark Collateral");

NOW, THEREFORE, Administrative Agent hereby releases and terminates its security interests in, liens on, and all other rights in, to and under the Trademark Collateral.
