**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

August 28, 2017

This Release of Security Interest in Trademarks (“Release”) is made as of August 28, 2017, by BANK OF AMERICA, N.A., as administrative agent (the “Administrative Agent”), a United States national banking association whose address is 135 S. LaSalle Street, Chicago, Illinois 60603, in favor of CORSAIR MEMORY, INC. a Delaware corporation with an address at 46221 Landing Parkway, Fremont, California 94538 and CORSAIR COMPONENTS, INC., a Delaware corporation with an address at 46221 Landing Parkway, Fremont, California 94538 (each, a “Grantor” and collectively, the “Grantors”).

WHEREAS, the Grantors entered into a certain Security and Pledge Agreement dated as of July 11, 2014, with the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the “Security Agreement”), and a Notice of Grant of Security Interest in Trademarks dated as of July 11, 2014, notice of which was recorded on July 16, 2014 at the United States Patent and Trademark Office at Reel 5323, Frame 0469 (the “Trademark Security Agreement”).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, the Grantors granted the Administrative Agent, under the terms of the Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to its Collateral, including the trademarks listed in Schedule I.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all Collateral, including such trademark as herein provided.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, does hereby unconditionally and expressly releases, terminates and forever discharges and extinguishes any and all of its right, title and interest in and to any and all liens and security interests it may have in the Collateral of the Grantors, including the trademarks listed in Schedule I, and retransfers and reassigns to Grantors the Security Interest and all of the Administrative Agent’s right, title and interest in, to and under the Released Collateral and terminates the Trademark Security Agreement. The Administrative Agent will take all such further actions, execute and deliver, at the request and cost of Grantors such further instruments, documents and release forms as Grantors may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.


