NOTICE OF SECURITY INTEREST
U.S. TRADEMARKS

March 11, 2022

WHEREAS, the entity listed on the signature page hereto (the "**Grantor**"), has adopted, used and is using the United States trademarks listed on the annexed Schedule A, which trademarks are registered in or subject to the trademark applications filed in the United States Patent and Trademark Office (the "**Trademarks**");

WHEREAS, pursuant to that certain Credit Agreement, dated as of even date herewith (as may be amended, modified, supplemented or restated from time to time, the "**Credit Agreement**"; all capitalized terms used herein and not defined herein have the meanings given in the Credit Agreement), by and among SHELTERED WINGS, INC., d/b/a VORTEX OPTICS, a Wisconsin corporation (the "**Borrower**"), the GUARANTORS (as defined therein) party thereto, the LENDERS (as defined therein) party thereto and PNC BANK, NATIONAL ASSOCIATION, as administrative agent for the Lenders (in such capacity, the "**Administrative Agent**"), the Grantor has entered into that certain Patent, Trademark and Copyright Security Agreement, dated as of even date herewith (the "**IP Security Agreement**") in favor of the Administrative Agent (for itself and for the benefit of the Lenders); and

WHEREAS, pursuant to the IP Security Agreement, the Grantor has granted to the Administrative Agent (for itself and for the benefit of the Lenders), a continuing security interest in, all right, title and interest of the Grantor in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, claims for infringement and proceeds of sale or other disposition thereof (the "**Trademark Collateral**") to secure the payment and performance of the Obligations (as defined in the Credit Agreement). For the avoidance of doubt, during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law, the Trademark Collateral shall not include any applications filed in the United States Patent and Trademark Office to register trademarks or service marks on the basis of the Grantor's "intent to use" such trademarks or service marks unless and until the filing of a "Statement of Use" or "Amendment to Allege Use" has been filed and accepted.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Grantor does hereby confirm its grant to the Administrative Agent (for itself and for the benefit of the Lenders) of a continuing security interest in the Trademark Collateral to secure prompt payment and performance of the Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent (for itself and for the benefit of the Lenders) with respect to its grant of a security interest in the Trademark Collateral pursuant to the IP Security Agreement made and granted hereby are more fully set forth in the IP Security Agreement, the


terms and provisions of which are hereby incorporated herein by reference as if fully set forth in this Notice of Security Interest.

This Notice of Security Interest shall be governed by and construed in accordance with the laws of the State of New York applicable to contracts made and to be performed in such State. The Administrative Agent's address is 500 First Avenue, Pittsburgh, PA 15219.


