

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Pillsbury (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**

### **Withdrawing your consent**

### **Consequences of changing your mind**

### **All notices and disclosures will be sent to you electronically**
