NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST (TRADEMARKS)

This NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST (TRADEMARKS), dated as of April 19, 2022 (this "Notice"), is entered into among (i) Goldman Sachs Bank USA, as the resigning Administrative Agent and the resigning Collateral Agent (in such capacities, the "Resigning Agent" or "Goldman Sachs") under the Credit Agreement (as defined below), (ii) Wells Fargo Bank, National Association, as the successor Administrative Agent and the successor Collateral Agent (in such capacities, the "Successor Agent" or "Wells Fargo") under the Credit Agreement and pursuant to the Agency Transfer Agreement (as defined below), (iii) Big Tex Trailer Manufacturing, LLC, a Texas limited liability company, (iv) BWISE Manufacturing, LLC, a Pennsylvania limited liability company, (v) Carry-On Trailer, Inc., a Virginia corporation, (vi) Circle J Trailers, Inc., an Idaho corporation, (vii) Contract Manufacturer, L.L.C., an Oklahoma limited liability company, (viii) PJ Trailers Manufacturing, Inc., a Texas corporation, (ix) RC Trailers, Inc., a Delaware company, and (x) TexTrail, Inc., a Texas corporation (entities set forth in clauses (iii) through (x), collectively, the "Grantors").

WHEREAS, *inter alia*, American Trailer World Corp., a Delaware corporation (the "Borrower"), Resigning Agent and the other parties named therein have entered into that certain Amended and Restated ABL Credit Agreement, dated as of March 5, 2021 (as amended on the date hereof and as further amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to the Credit Documents, the Credit Parties granted to the Resigning Agent a security interest in certain collateral;

WHEREAS, the Resigning Agent, in its capacity as Collateral Agent, and certain Credit Parties entered into certain trademark security agreements from time to time (collectively, the "Trademark Security Agreements");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office with the Reel/Frame numbers identified on Schedule A attached hereto; and

WHEREAS, pursuant to that certain Agency Resignation, Appointment and Assumption Agreement, dated as of the date hereof, by and among Goldman Sachs, Wells Fargo, and each Credit Party (the "Agency Transfer Agreement"), the Resigning Agent resigned as, and Successor Agent was appointed and accepted appointment as, the Administrative Agent and Collateral Agent and succeeds to all the rights, powers, privileges and duties of the Resigning Agent as Administrative Agent and Collateral Agent under the Credit Documents, including the Trademark Security Agreements.

NOW, THEREFORE, the parties agree as follows:

- 1. <u>Defined Terms</u>. Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Credit Agreement.
- 2. <u>Succession and Replacement of Agency</u>. Pursuant to the terms and conditions set forth in the Agency Transfer Agreement, the Resigning Agent has ceased to be the Administrative Agent and the Collateral Agent under the Credit Documents and is succeeded to and replaced by the Successor Agent as the Administrative Agent and the Collateral Agent under the Credit Documents, and the Resigning Agent transferred, assigned, granted and conveyed unto the Successor Agent, without representation, warranty or recourse, all of its right, title and interest in and to the Trademark Security Agreements, in its capacity as Collateral Agent, with all attendant liens, rights, title, assignments and interests (including security interests) pertaining to or arising from the Security Documents, including in and to the Collateral scheduled

on the Trademark Security Agreements. Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to the Resigning Agent under the Credit Documents, including the Trademark Security Agreements and the Collateral identified on Schedule A attached hereto, which security interest is now succeeded by and transferred to the Successor Agent.

3. <u>Incorporation</u>. All terms set forth in the Agency Transfer Agreement are hereby incorporated herein by reference with the same force and effect as though fully set forth herein. To the extent that the terms set forth herein are inconsistent with the terms of the Agency Transfer Agreement, the terms set forth in the Agency Transfer Agreement shall apply.
