**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this “**Assignment**”) is made, entered into and effective as of the 19th day of January, 2022, by and between December Acquisition Co LLC, a Delaware limited liability company (“**Assignee**”), [REDACTED], a Delaware limited partnership (“[REDACTED]”), and Death Row Acquisition LLC, a Delaware limited liability company (the “**Assignor**”). [REDACTED] Assignor and Assignee are sometimes referred to herein individually as a “**Party**” and collectively as the “**Parties.**”

**RECITALS**

**WHEREAS**, [REDACTED], Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of the date hereof (the “**APA**”);

**WHEREAS**, Assignor owns all rights, title and interest in the trademarks listed in the attached **Schedule A**, including all applications and registrations pertaining thereto (collectively, the “**Trademarks**”), and all common-law rights associated therewith, together with the goodwill arising from the use of the Trademarks by Assignor, [REDACTED] and/or any of its their respective predecessors in interest, related companies, and/or licensees (collectively with the Trademarks, the “**Intellectual Property**”);

**WHEREAS**, Assignor desires to transfer, and [REDACTED] desires for Assignor to transfer, to Assignee all right, title and interest in and to the Intellectual Property;

**WHEREAS**, Assignee is desirous of acquiring all of Assignor’s right, title and interest in and to the Intellectual Property; and

**WHEREAS**, to the extent any of the Trademarks are currently pending U.S. applications with an intent-to-use filing basis, each of Assignor and [REDACTED] acknowledges that Assignee is the successor of that portion of Assignor’s business to which the trademarks in such applications pertain.

**NOW THEREFORE**, in consideration of the mutual benefits to be derived from this Assignment and in further consideration of the covenants and agreements contained in the APA, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree to the foregoing and as follows:

1. **Assignment.** Assignor hereby forever and irrevocably, without reservation, assigns, transfers, sells, conveys, and delivers to Assignee, its successors and assigns, all right, title and interest in and to the Intellectual Property throughout the world, together with the goodwill represented and symbolized thereby, including the right to sue and recover and have damages and profits for any and all past, present or future infringements, all to be held and enjoyed by Assignee for its own use and benefit, and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made.

2. **Further Assurances and Covenant.** Following the Effective Date, upon Assignee's request, and without further consideration, Assignor [REDACTED], as applicable, shall execute and deliver to Assignee all documents and instruments, and take all other actions as may be reasonably required to secure, complete or vest Assignor's right, title and interest in and to the Intellectual Property.

3. **Governing Law.** This Assignment and all proceedings (whether based on contract, tort or otherwise) arising out of or relating to this Assignment or the actions of the parties in the negotiation, administration, performance and enforcement hereof, shall be governed by, and construed and enforced in accordance with, the laws of the State of Delaware, without regard to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Delaware. In addition, each of the parties hereto irrevocably (i) submits to the personal jurisdiction of the Delaware Court of Chancery in and for New Castle County, or in the event (but only in the event) that such Delaware Court of Chancery does not have subject matter jurisdiction over such dispute, the United States District Court for the District of Delaware, or in the event (but only in the event) that such United States District Court also does not have jurisdiction over such dispute, any Delaware State court sitting in New Castle County, in the event any dispute (whether in contract, tort or otherwise) arises out of this Assignment or the transactions contemplated hereby, (ii) agrees that it will not attempt to deny or defeat such personal jurisdiction by motion or other request for leave from any such court, (iii) waives any objection to the laying of venue of any action relating to this Assignment or the transactions contemplated hereby in such court, (iv) waives and agrees not to plead or claim in any such court that any action relating to this Assignment or the transactions contemplated hereby brought in any such court has been brought in an inconvenient forum, and (v) agrees that it will not bring any action relating to this Assignment or the transactions contemplated hereby in any court other than the Delaware Court of Chancery in and for New Castle County, or in the event (but only in the event) that such Delaware Court of Chancery does not have subject matter jurisdiction over such action, the United States District Court for the District of Delaware, or in the event (but only in the event) that such United States District Court also does not have jurisdiction over such action, any Delaware State court sitting in New Castle County.

4. **Successors and Assigns.** This Assignment shall be binding upon and shall inure to the benefit of the Parties and their respective successors and assigns.

5. **Amendment.** This Assignment may not be modified, amended, altered or supplemented except upon the execution and delivery of a written agreement executed by all Parties.

6. **Counterparts.** This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same Assignment.


