TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is dated as of January 31, 2022, by **WILMINGTON TRUST, NATIONAL ASSOCIATION** (“Wilmington Trust”), in its capacity as agent for the Secured Parties (as defined in the Security Documents) (in such capacity, together with its successors and assigns in such capacities, the “Agent”).

WHEREAS, **WELLS ENTERPRISES, INC.**, an Iowa corporation (“Enterprises”), **WEI SALES, LLC**, an Iowa limited liability company (the “Borrower”), the lenders party thereto as “Lenders” (such Lenders, together with their respective successors and assigns in such capacity, each, individually, a “Lender” and, collectively, the “Lenders”), and Agent, are party to a certain Credit Agreement dated as of April 27, 2020 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, each Grantor (as defined therein) and certain other grantors have executed and delivered that certain Guaranty and Security Agreement, dated as of April 27, 2020 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “Guaranty and Security Agreement”);

WHEREAS, pursuant to the Credit Agreement and the Guaranty and Security Agreement, each Grantor (as defined therein) and the Agent, for the benefit of the Secured Parties, entered into the Trademark Security Agreement dated as of April 27, 2020 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the “Security Agreement,” and together with the Credit Agreement and the Guaranty and Security Agreement, the “Security Documents”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on April 28, 2020, at Reel 6925, Frame 0137; and

WHEREAS, in connection with the payment in full of the obligations under the Credit Agreement and termination of the security interests securing such obligations pursuant to a pay-off letter dated as of October 29, 2021 from the Agent, Grantors have requested that Agent release its security interests in the Trademark Collateral (as defined in the Security Agreement), including the Trademarks listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Agent, of behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Security Agreement and fully and irrevocably discharges, releases and terminates any and all security interests that it has or had pursuant to the Security Documents in any and all right, title, and interest that they may have in, to and under the Trademark Collateral (as defined in the Security Agreement), including the following:

(a) all of its Trademarks including those referred to on Schedule I;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, including right to receive any damages, or (ii) injury to the goodwill associated with any Trademark.

2. DEFINED TERMS. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Documents, and this Release shall be subject to the rules of construction set forth in Section 1(b) of the Guaranty and Security Agreement, which rules of construction are incorporated herein by this reference, *mutatis mutandis*.



THIS RELEASE SHALL BE SUBJECT TO THE PROVISIONS REGARDING CHOICE OF LAW AND VENUE, JURY TRIAL WAIVER, AND JUDICIAL REFERENCE SET FORTH IN THE SECURITY DOCUMENTS, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, *MUTATIS MUTANDIS*.

4. FURTHER ASSURANCES. Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


