- 2. <u>Further Actions</u>. Assignor hereby agrees to execute and deliver any additional documents, at no cost to Assignee, that Assignee reasonably determines may be necessary, or that may be required under applicable law, to give effect to and record Assignees' ownership of any trademark rights in the Marks.
- 3. <u>Counterparts.</u> This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.
