RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE ("<u>Release</u>") dated as of July 5, 2022, from WILMINGTON TRUST, NATIONAL ASSOCIATION, as Collateral Agent (in such capacity, the "<u>Collateral Agent</u>") to THE FRESH MARKET, INC. (the "Pledgor").

If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the IP Collateral, the Collateral Agent, without recourse, representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Pledgor.
- 3. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of the State of New York.
