**ASSIGNOR HEREBY** covenants and warrants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

**ASSIGNOR HEREBY** further covenants and agrees that it will, upon request, execute and deliver to ASSIGNEE any and all additional papers and generally do all other and further lawful acts deemed necessary by said ASSIGNEE to carry out the intent and purpose of this Intellectual Property Assignment.

This Intellectual Property Assignment is given pursuant to the terms of the Purchase Agreement. The terms and conditions of the Purchase Agreement are incorporated herein by reference. In the event of a conflict or inconsistency between the provisions of this Intellectual Property Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement will prevail.
