**ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS**  
**NUNC PRO TUNC**

WHEREAS, Hawkeye Acquisition, Inc. (f/k/a Meredith Corporation), an Iowa corporation (“Hawkeye”), KPHO Broadcasting Corporation, an Arizona corporation (“KPHO”), and KVVU Broadcasting Corporation, a Nevada corporation (“KVVU” and, collectively with Hawkeye and KPHO, the “Assignors”) are the record owners of certain marks registered in the U.S. Patent & Trademark Office (“Registered Marks”), certain marks in use for which trademark registration applications have been filed in the U.S. Patent & Trademark Office (“Trademark Applications”), and certain marks for which Assignors have a bona fide intent to use and for which intent-to-use trademark registration applications have been filed in the U.S. Patent & Trademark Office (“ITU Trademark Applications”), including, without limitation, the marks, registrations, and applications identified or set forth in Schedule A attached hereto;

WHEREAS, on or about December 31, 2021, pursuant to an Amended and Restated Agreement and Plan of Merger (the “Merger Agreement”), each Assignor merged with and into Gray Media Group, Inc., a Delaware corporation (“Assignee”), and as a result each Assignor transferred all its interest in the said Registered Marks, Trademark Applications, and ITU Trademark Applications together with the goodwill of the business symbolized by the marks and the above-identified registrations thereof to Assignee by operation of law; and

WHEREAS, Assignee became the sole and entire owner of the marks, including the Registered Marks, the Trademark Applications, the ITU Trademark Applications, the goodwill of the business symbolized by said marks, and the portion of the business of the Assignor to which the marks of the ITU Trademark Applications pertain;

WHEREAS, each Assignor now desires to enter into this Assignment Nunc Pro Tunc formalizing the prior transfer to Assignee of the marks, associated goodwill, Registered Marks, Trademark Applications, ITU Trademark Applications, and portion of the business of each Assignor to which the marks of the ITU Trademark Applications pertain, including, without

limitation, as identified above and in Schedule A, in a form acceptable for recordation by the U.S. Patent & Trademark Office; and

WHEREAS, Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdiction to record and register this Assignment upon request by Assignee.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, each Assignor does assign, convey, and transfer unto Assignee the entire right, title and interest in and to said marks, registrations and applications thereof, including all renewals and extensions of any such application, registration, and filing, the right to receive royalties, the right to sue for damages and other remedies in respect of any infringement of the marks which may have occurred before the effective date of this assignment, together with the goodwill of the business symbolized by said marks. This assignment is expressly made NUNC PRO TUNC, and this assignment is to have the same legal force and effect as if executed on December 31, 2021. This assignment is subject in all events to the terms and conditions of the Merger Agreement. In the event of a conflict or inconsistency between this assignment and the Merger Agreement, the terms of the Merger Agreement will prevail. Nothing in this assignment is intended to waive, modify, expand or limit the terms and conditions of the Merger Agreement.
