Reference is hereby made to (i) that certain Credit Agreement dated as of the date hereof by and among Debtor, as the borrower, Daou Brothers, LLC and Daou Family, LLC, as guarantors, and Lender ("Daou Vineyards Credit Agreement"), (ii) that certain Credit Agreement dated as of the date hereof by and among Daou Brothers, LLC, as the borrower, Daou Vineyards, LLC and Daou Family, LLC, as guarantors, and Lender ("Daou Brothers Credit Agreement"), and (iii) that certain Credit Agreement dated as of the date hereof by and among Daou Family, LLC, as the borrower, Daou Vineyards, LLC and Daou Brothers, LLC, as guarantors, and Lender ("Daou Family Credit Agreement"), in each case, as amended, restated, supplemented or otherwise modified from time to time (collectively, "Credit Agreements").

In connection with the Daou Vineyards Credit Agreement, Debtor entered into that certain Security Agreement dated as of the date hereof by and among Debtor, certain affiliates of Debtor, and Lender (as amended, restated, supplemented or otherwise modified from time to time, the "Daou Vineyards Security Agreement"). In connection with the Daou Brothers Credit Agreement, Debtor entered into that certain Security Agreement dated as of the date hereof by and among Debtor, certain affiliates of Debtor, and Lender (as amended, restated, supplemented or otherwise modified from time to time, the "Daou Brothers Security Agreement"). In connection with the Daou Family Credit Agreement, Debtor entered into that certain Security Agreement dated as of the date hereof by and among Debtor, certain affiliates of Debtor, and Lender (as amended, restated, supplemented or otherwise modified from time to time, the "Daou Family Security Agreement"; together with the Daou Vineyards Security Agreement and the Daou Brothers Security Agreement, each a "Security Agreement" and collectively, "Security Agreements").

Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Lender may have in any other collateral described in the Security Agreements or otherwise. Capitalized terms that are undefined herein have the meanings ascribed thereto in the Security Agreements.
