**EXECUTION VERSION**

This Agreement and the rights and obligations evidenced hereby are subordinate in the manner and to the extent set forth in that certain Subordination Agreement (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time pursuant to the terms thereof, the "**Subordination Agreement**") dated as of October 18, 2022 among Guarantor (as defined in the Subordination Agreement), Borrower (as defined herein), Lender (as defined herein) and SILICON VALLEY BANK, a California corporation ("**Senior Creditor**"), to the Obligations (as defined in the Senior Loan Agreement, as defined herein), including, but not limited to, interest, owed by Borrower and each other Grantor (as defined herein) to Senior Creditor from time to time and liens granted by Borrower and each other Grantor in favor of Senior Creditor to secure payment and performance of such Obligations (as defined in the Senior Loan Agreement), in each case, pursuant to that certain Amended and Restated Loan and Security Agreement dated as of March 30, 2022 (the "**Senior Loan Agreement**") among Borrower and Senior Creditor, and the other Senior Loan Documents (as defined in the Subordination Agreement) in each case, as may be amended, restated, amended and restated, supplemented or otherwise modified from time to time.

**INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Intellectual Property Security Agreement (this "**Agreement**") is entered into as of October 18, 2022, by and between TRINITY CAPITAL INC., a Maryland corporation, with its principal office located at 1 N. 1st Street, Floor 3, Phoenix AZ, 85004 ("**Lender**"), VOX MEDIA, LLC, a Delaware limited liability company ("**Company**") with its principal place of business located at 1201 Connecticut Ave NW, 11<sup>th</sup> Floor, Washington, DC 20036 and each other undersigned Subsidiary (each such Subsidiary, together with Company, individually and collectively, as the context requires, jointly and severally, "**Grantor**").

RECITALS

A. Lender has agreed to make certain advances of money and to extend certain financial accommodations (the "**Loans**") to each of Company and VOX MEDIA HOLDINGS, INC., a Delaware corporation (collectively the "**Borrower**") in the amounts and manner set forth in that certain Loan and Security Agreement, dated as of October 18, 2022 (as may be amended, amended and restated, supplemented, restated or otherwise modified from time to time, the "**Loan Agreement**"). Capitalized terms used herein are used as defined in the Loan Agreement. Lender is willing to make the Loans to Borrower, but only upon the condition, among others, that Grantor shall grant to Lender a security interest in its Copyrights, Trademarks and Patents (as each term is described below) to secure the obligations of Grantor to Lender.

B. Pursuant to the terms of the relevant Loan Documents, Grantor has granted to Lender a security interest in all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of Grantor's obligations to Lender, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

1. Grant of Security Interest. To secure Grantor's obligations to Lender, Grantor grants and pledges to Lender a security interest in all of Grantor's right, title and interest in, to and under its Intellectual Property that constitutes Collateral (all of which shall collectively be called the "**Intellectual Property Collateral**"), including, without limitation, the following:

(a) Any and all copyrights registered by and copyright applications pending with the United States Copyright Office, including without limitation those set forth on Exhibit A attached hereto (collectively, the "**Copyrights**");

(b) All patents and patent applications issued by or pending with the United States Patent and Trademark Office, including without limitation those set forth on Exhibit B attached hereto (collectively, the "**Patents**");

(c) Any trademark registration issued by, and trademark application pending with, the United States Patent and Trademark Office, and the entire goodwill of the business of Grantor connected with and symbolized by such trademark registrations and applications, including without limitation those set forth on Exhibit C attached hereto (collectively, the "**Trademarks**") (excluding any intent-to-use trademark applications filed in the United States Patent and Trademark Office, pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. Section 1051, prior to the accepted filing of a "Statement of Use" and issuance of a "Certificate of Registration" pursuant to Section 1(d) of the Lanham Act or an accepted filing of an "Amendment to Allege Use" whereby such intent-to-use trademark application is converted to a "use in commerce" application pursuant to Section 1(c) of the Lanham Act); and

(d) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing

2. Recordation. Grantor authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other government officials in record and register this Agreement upon request by Lender.

3. Authorization. Grantor hereby authorizes Lender to (a) modify this Agreement unilaterally by amending the exhibits to this Agreement to include any Intellectual Property Collateral registered by the United States Copyright Office or filed with or issued by the United States Patent and Trademark Office (except for any intent-to-use trademark applications filed in the United States Patent and Trademark Office, pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. Section 1051, prior to the accepted filing of a "Statement of Use" and issuance of a "Certificate of Registration" pursuant to Section 1(d) of the Lanham Act or an accepted filing of an "Amendment to Allege Use" whereby such intent-to-use trademark application is converted to a "use in commerce" application pursuant to Section 1(c) of the Lanham Act), which Grantor obtains subsequent to the date of this Agreement, and (b) file a duplicate original of this Agreement containing amended exhibits reflecting such new Intellectual Property Collateral.

4. Loan Documents. This Agreement has been entered into pursuant to and in conjunction with the Loan Agreement, which is hereby incorporated by reference. The provisions of the Loan Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of Lender with respect to the Intellectual Property Collateral are as provided by the Loan Agreement and related documents, and nothing in this Agreement shall be deemed to limit such rights and remedies.

5. Execution in Counterparts. This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or in electronic (i.e., "pdf" or "tif" format) shall be effective as delivery of a manually executed counterpart of this Agreement.

6. Successors and Assigns. This Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.

7. Governing Law. This Agreement and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).

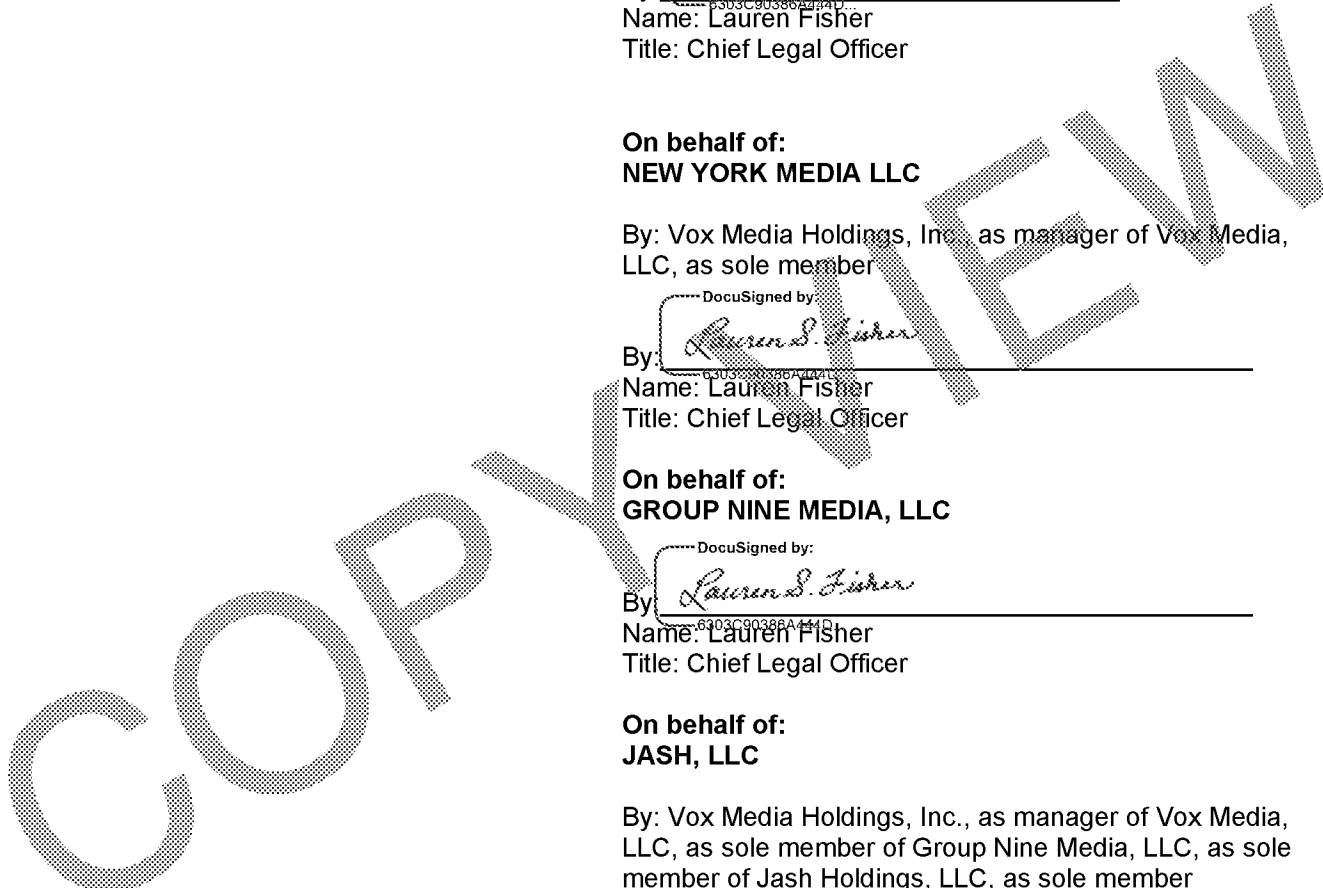




