Ignite Global, Inc., a Delaware corporation (the "Corporation"), hereby certifies that:

1. The name of the corporation is **IGNITE GLOBAL, INC.** The Corporation was originally incorporated under the name **ALL IN BITS INC.**

2. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on February 28, 2014. A Certificate of Amendment to the Certificate of Incorporation was filed on July 20, 2018. An Amended and Restated Certificate of Incorporation was filed on March 5, 2019. A Second Amended and Restated Certificate of Incorporation was filed on November 16, 2020, as amended by that certain Certificate of Amendment of Second Amended and Restated Certificate of Incorporation, which was filed on March 23, 2022 (the "Charter").

3. This Second Certificate of Amendment to the Charter (the "Certificate of Amendment") amends Article I of the Charter to read in its entirety as follows:

"The name of this corporation is **ALL IN BITS INC.** (the "Corporation")."

4. This Certificate of Amendment has been duly adopted by the Board of Directors of the Corporation in accordance with Section 242 of the General Corporation Law of the State of Delaware.
