NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of March 19, 2019, by PNC BANK, NATIONAL ASSOCIATION, as Collateral Agent (as defined in that certain Credit Agreement dated December 9, 2015) (together with its successors and assigns in such capacity, “Agent”), in favor of BLISS WORLD LLC, a Florida limited liability company; IDEAL IMAGE DEVELOPMENT CORPORATION, a Florida corporation; MANDARA SPA LLC, a Delaware limited liability company; and STEINER EDUCATION GROUP, INC., a Florida corporation (together with its successors and assigns, “Grantors”). All terms referred to herein but not defined herein are given the meaning set forth in the Grant (as defined below).

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks, dated as of December 9, 2015 (the “Grant”) by the Grantors in favor of Agent, and recorded in the United States Patent and Trademark Office on December 30, 2015, at Reel/ Frame 5699/ 0640, the Grantors assigned to and granted to Agent, for the benefit of the Secured Creditors (as defined in the Security Agreement as defined in the Grant), a lien on and security interest in all right, title and interest of the Grantors in, to and under (i) the trademark registrations and applications listed on Schedule A hereto (the “Marks”) together with the goodwill of the business symbolized by such trademark registrations and applications, (ii) all Proceeds (as defined in the Security Agreement as defined in the Grant) and products of the Marks, and (iii) all causes of action arising prior to or after the date of the Grant (but prior to the Termination Date) for infringement of any of the Marks or unfair competition regarding the same (collectively, the “Trademark Collateral”).

WHEREAS, Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office the release, relinquishment and discharge of its liens on and security interest in the Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged by Grantors and Agent, Agent hereby terminates, cancels, reassigns relinquishes, releases and discharges its continuing security interest in all of the right, title and interest of Agent in the Trademarks Collateral, and all goodwill associated therewith. The Agent will take such further actions, execute and deliver, at the request and cost of Grantors, such further instruments, documents and release forms as Grantors may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interest upon such Trademark Collateral. The Agent represents and warrants that it has the full power and authority to execute this Release.


