TERMINATION TO TRADEMARK SECURITY AGREEMENT

This **TERMINATION TO TRADEMARK SECURITY AGREEMENT** (this "*Termination*"), dated as of January 3, 2023, is executed by OrbiMed Royalty & Credit Opportunities III, LP ("*Administrative Agent*"), with an address at 601 Lexington Avenue, 54th Floor, New York, NY 10022, in favor of Oyster Point Pharma, Inc., a Delaware corporation ("*Grantor*"), with an address at 202 Carnegie Center Drive, Suite 109, Princeton, NJ 08540.

RECITALS

WHEREAS, Grantor and Administrative Agent entered into that certain Security Agreement, dated as of August 5, 2021 (as amended or otherwise modified from time to time, the "*Security Agreement*");

WHEREAS, in connection with the Security Agreement, Grantor and Administrative Agent entered into that certain Trademark Security Agreement dated as of August 5, 2021 (as amended or otherwise modified from time to time, the "*Agreement*") pursuant to which Grantor granted to Administrative Agent a security interest in the Trademark Collateral (as defined in the Agreement); and

WHEREAS, Administrative Agent has agreed to terminate and release its security interest in the Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing, Administrative Agent agrees as follows:

1. Administrative Agent hereby terminates its security interest in the Trademark Collateral, including without limitation the trademarks listed on *Schedule 1* hereto, which security interest was evidenced by the recordation of the Security Agreement with the United States Patent and Trademark Office on August 16, 2021, in Reel/Frame 7393/0031.
2. Administrative Agent may record this Termination with the United States Patent and Trademark Office at the expense of Grantor.
3. Administrative Agent hereby irrevocably authorizes Grantor or Grantor's agent to record this Termination with the United States Patent and Trademark Office and any other relevant governmental authority.
4. This Termination and the rights and obligations of the parties under this Termination shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
