INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Agreement**”) is made as of January 12, 2023 (the “**Effective Date**”) between **DICK CLARK PRODUCTIONS, LLC**, a Delaware limited liability company (the “**Grantor**”), in favor of **SB CORPORATE FUNDING LLC**, as administrative agent for the Lenders (in such capacity, the “**Administrative Agent**”).

RECITALS:

WHEREAS, reference is made to that certain Guaranty and Collateral Agreement, dated as of January 12, 2023 (as it may be amended, restated, supplemented or otherwise modified from time to time (the “**Guaranty and Collateral Agreement**”); capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Guaranty and Collateral Agreement), by and among PME-DCP HOLDCO, LLC, as holdings, the Grantor, as the borrower, the other grantors from time to time party thereto, and the Administrative Agent; and

WHEREAS, under the terms of the Guaranty and Collateral Agreement, the Grantor has (i) as collateral security for the Secured Obligations, granted to the Administrative Agent a security interest in and continuing Lien on all of the Grantor’s right, title and interest in, to and under the Collateral (as defined in the Guaranty and Collateral Agreement), including, without limitation, certain Intellectual Property of the Grantor and (ii) agreed to execute this Agreement for recording with the United States Patent and Trademark Office and other applicable Governmental Authorities.

NOW, THEREFORE, in consideration of the premises and the agreements, provisions and covenants herein contained, the Grantor and the Administrative Agent agree as follows:

Section 1. Grant of Security. As collateral security for the Secured Obligations, the Grantor hereby grants to the Administrative Agent a security interest in and continuing lien on all of the Grantor’s right, title and interest in, to and under the following, but excluding any Excluded Property (collectively, the “**Intellectual Property Collateral**”):

(a) (i) (A) All trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers and domain names, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto (the “**Trademarks**”) and (B) all agreements, whether written or oral, providing for the grant by or to the Grantor of any right to use any Trademark, in each case of clauses (A) and (B) above, whether arising under the United States or any other country or any political subdivision thereof, including, without limitation, those listed on **Schedule 1** hereto; (ii) all reissues, continuations, renewals, extensions and continuations-in-

part thereof and amendments thereto; (iii) all income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto including damages and payments for past, present or future infringements or other violations thereof; (iv) all rights corresponding thereto throughout the world; (v) all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all Proceeds and damages therefrom; and (vi) all Proceeds of the foregoing, including all licenses, fees, royalties, income, payments, claims, damages, and proceeds of suit, but for the avoidance of doubt excluding any intent to use applications for registrations of trademarks currently filed or filed in the future with the United States Patent and Trademark Office for which a statement of use under 15 U.S.C. § 1051(d) or amendment to allege use under 15 U.S.C. § 1051(c) has not yet been filed and accepted, to the extent, if any, that, and solely during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark application under applicable law.

Section 2. Recordation. The Grantor authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office and any other applicable government officer record this Agreement.

Section 3. Counterparts. This Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts and each such counterpart shall be deemed to be an original, but all such counterparts shall together constitute but one and the same agreement. Receipt of an executed signature page to this Agreement by facsimile or other electronic transmission shall constitute effective delivery thereof. Electronic records of this Agreement maintained by the Administrative Agent shall be deemed to be originals. The words “execution,” “signed,” “signature” and words of like import in this Agreement or in any amendment or modification thereof shall be deemed to include electronic signatures or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act; provided that notwithstanding anything contained herein to the contrary the Administrative Agent is under no obligation to agree to accept electronic signatures in any form or in any format unless expressly agreed to by the Administrative Agent pursuant to procedures approved by it; provided, further, that without limiting the foregoing, upon the request of the Administrative Agent, any electronic signature shall be promptly followed by such manually executed counterpart.

Section 4. Governing Law. This Agreement and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the law of the State of New York.

Section 5. Conflict Provision. This Agreement has been entered into in conjunction with the provisions of the Guaranty and Collateral Agreement and the Credit Agreement. The rights and remedies of each party hereto with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Guaranty and Collateral


Agreement and the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are in conflict with the Guaranty and Collateral Agreement or the Credit Agreement, the provisions of the Guaranty and Collateral Agreement or the Credit Agreement shall govern.






