TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 23, 2023 (“Release”), is made by **U.S. BANK NATIONAL ASSOCIATION**, a national banking association, (“Collateral Agent”), in favor of **COASTAL FARM & HOME SUPPLY LLC**, an Oregon limited liability company (the “Grantor”).

WHEREAS, pursuant to (i) that certain Pledge and Security Agreement dated as of December 23, 2021 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantor and the other parties thereto in favor of the Collateral Agent, and (ii) that certain Assignment for Security - Trademarks dated as of December 23, 2021 by the Grantor in favor of the Collateral Agent (“Trademark Agreement”), Grantor granted to the Collateral Agent, a lien on and security interest in all of Grantor’s right, title and interest in, to and under the Collateral (as defined in the Trademark Agreement);

WHEREAS, the Trademark Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 23, 2021 at Reel 7540 Frame 0795.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Agreement, as applicable.

SECTION 2. Termination and Release. Collateral Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the Grantor’s right, title, and interest in, to, and under the Collateral (as defined in the Trademark Agreement), including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement and the Trademark Agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Collateral under the Security Agreement or the Trademark Agreement, the Collateral Agent, without recourse, representation or warranty of any kind, hereby irrevocably re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor;

(b) without representation or warranty of any kind, terminates and cancels the Trademark Agreement; and


(c) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

SECTION 4. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
