**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of February 27, 2023, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (“Administrative Agent”) in favor of **Orveon Global US LLC (formerly known as bareMinerals US Buyer LLC)**, a Delaware limited liability company with an address at 500 5th Ave, 26th Floor, New York, New York 10110, **LAURA MERCIER US BUYER LLC**, a Delaware limited liability company with an address at 500 5th Ave, 26th Floor, New York, New York 10110, and **BUXOM US BUYER LLC**, a Delaware limited liability company with an address at 500 5th Ave, 26th Floor, New York, New York 10110 (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain intellectual property security agreement dated December 6, 2021 (the “IP Security Agreement”) with Administrative Agent, notice of which was submitted to the United States Copyright Office, and recorded on December 6, 2021 at the United States Patent and Trademark Office at Reel 7521, Frame 0128 and Reel 058320, Frame 0660.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Grantors granted the Administrative Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of their right, title and interest in and to the IP Collateral, including without limitation the Trademarks listed in **Schedule 1**, the Patents listed in **Schedule 2**, and the Copyrights listed in **Schedule 3**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any and all of its interest in the IP Collateral of the Grantors, including all of the goodwill of each such Grantor’s business symbolized by the Trademarks and associated therewith, and assigns, transfers and conveys to the Grantors (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) the Security Interest in such IP Collateral.
