STEP 35(a) INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Agreement"), dated as of May 25, 2023, is entered into by and between Emerson Electric Co., a Missouri corporation ("Emerson"), on behalf of itself and each Retained Subsidiary organized in the United States, including those listed on Appendix I hereto (the "Emerson US Retained Subsidiaries"), and Emersub CXIII, Inc., a Delaware corporation ("NewCo Corp"). Capitalized terms not otherwise defined herein shall have the meanings set forth in the Transaction Agreement (as defined below), unless the context herein otherwise requires.

WITNESSETH:

WHEREAS, in connection with the transactions contemplated by that certain Transaction Agreement, dated as of October 30, 2022, by and among Emerson, Emerald JV Holdings L.P., a Delaware limited partnership, BCP Emerald Aggregator L.P., a Delaware limited partnership, and Emerald Debt Merger Sub L.L.C., a Delaware limited liability company (as it may be amended, supplemented or otherwise modified from time to time) (the "**Transaction Agreement**"), the parties hereto desire to enter into this Agreement to consummate certain transactions contemplated by the Transaction Agreement on the terms set forth herein;

WHEREAS, in connection with the transactions contemplated by that certain Transaction Agreement, including the transfer of Assigned IP Assets contemplated by Step 35(a) of the Master Step Plan, NewCo Corp has agreed to accept and acquire from Emerson and the Emerson US Retained Subsidiaries, and Emerson has agreed to, and to cause the Emerson US Retained Subsidiaries to, contribute, convey, transfer, assign and deliver, or cause to be contributed, conveyed, transferred, assigned and delivered, to NewCo Corp, all of Emerson's and the Emerson US Retained Subsidiaries' right, title and interest in, to and under the Assigned IP Assets, including the Trademarks set forth on Exhibit A and the Patents set forth on Exhibit B;

WHEREAS, in connection with the foregoing, Emerson and the Emerson US Retained Subsidiaries desire to contribute, convey, transfer, assign and deliver to NewCo Corp, and NewCo Corp desires to accept and acquire from Emerson and the Emerson US Retained Subsidiaries, all of Emerson's and the Emerson US Retained Subsidiaries' right, title and interest in, to and under the Assigned IP Assets, including the Trademarks set forth on Exhibit A and the Patents set forth on Exhibit B; and

WHEREAS, the parties hereto wish to enter into this Agreement to effectuate the assignment to NewCo Corp of any right, title and interest of Emerson and the Emerson US Retained Subsidiaries in, to and under any Assigned IP Assets.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants set forth herein and other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Section 1. Transfers. Pursuant to Section 2.01(g) of the Transaction Agreement, effective on the date hereof, Emerson and the Emerson US Retained Subsidiaries shall, and hereby do, irrevocably contribute, convey, transfer, assign and deliver to NewCo Corp, and NewCo Corp shall, and hereby does, accept all of Emerson's and the Emerson US Retained Subsidiaries' right, title and interest in, to and under (i) the Assigned IP Assets, including the Trademarks set forth on Exhibit A, together with all goodwill associated therewith and symbolized thereby and all common-law rights related thereto, and the Patents set forth on Exhibit B, and, in each case, all registrations therefor that are secured as of the date hereof, in each case to be held and enjoyed by NewCo Corp for its own use and enjoyment, and for the use and enjoyment of NewCo Corp's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Emerson and the Emerson US Retained Subsidiaries if this assignment had not been made, and (ii) all past, current or future rights, claims, credits, causes of action or rights of set-off against third parties, including unliquidated rights under manufacturers' and vendors' warranties (and the right to receive all monies, proceeds, settlements and recoveries in connection therewith) to the extent related to any Assigned IP Assets.

Section 2. *Recordation*. The parties hereby authorize and request the Commissioner of Patents and Trademarks at the United States Patent and Trademark Office, and the corresponding entities or agencies in any other applicable jurisdictions, to record NewCo Corp as the assignee and owner of the Assigned IP Assets, including the Trademarks set forth on Exhibit A and the Patents set forth on Exhibit B, and to issue any and all registrations that are or may be secured, as of or after the date hereof, from the Assigned IP Assets to NewCo Corp, as assignee of Emerson's and the Emerson US Retained Subsidiaries' entire right, title and interest in, to, and under the same.

Section 3. *Governing Law*. This Agreement shall be governed by and construed in accordance with the law of the State of Delaware, without regard to conflicts of law principles.

Section 4. *Amendment*. This Agreement may not be amended or modified in any manner except by a written agreement executed by each of the parties hereto.

Section 5. *Counterparts*. This Agreement may be executed in any number of counterparts, each of which shall be an original with the same effect as if the signatures thereto and hereto were upon the same instrument.

Section 6. Severability. If any term, provision, covenant or restriction of this Agreement is held by a court of competent jurisdiction or other Governmental Authority to be invalid, void or unenforceable, the remainder of the terms, provisions, covenants and restrictions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated so long as the economic or legal substance of the transactions contemplated hereby is not affected in any manner materially adverse to any party. Upon such a determination, the parties shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in an

acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the fullest extent possible.

Section 7. Further Assurances. Each of the parties hereto shall (and Emerson shall cause each Emerson US Retained Subsidiary to) execute and deliver such additional agreements, documents and instruments, and shall take such further actions, as may be reasonably required to give full effect to the purpose and intent of this Agreement.

Section 8. *Conflicts*. This Agreement shall be without prejudice to the Transaction Agreement. In the event of any conflict or inconsistency between the terms of this Agreement and the Transaction Agreement, the terms of the Transaction Agreement shall control. In the event of any conflict between the terms of this Agreement, on the one hand, and (A) the Transfer Agreement, dated as of April 26, 2023, by and between Emerson and Copeland Comfort Control LP, as supplemented by the Step 38(e) Supplemental Intellectual Property Assignment Agreement, effective as of April 26, 2023 (collectively, the "Step 38(e) White Rodgers Transfer Agreement") or (B) the Transfer Agreement, dated as of May 24, 2023, by and between Emerson and Hermetic Motors LP (the "Step 38(d) Hermetic Motors Transfer Agreement"), on the other hand, the terms of the Step 38(e) White Rodgers Transfer Agreement or the Step 38(d) Hermetic Motors Transfer Agreement, as applicable, shall control. Without limiting the generality of the foregoing, any unregistered Intellectual Property Rights that were assigned pursuant to the Step 38(e) White Rodgers Transfer Agreement or the Step 38(d) Hermetic Motors Transfer Agreement, as applicable, shall not be deemed included in the Assigned IP Assets for purposes of this Agreement.
