**INTRA-GROUP IP DEED OF ASSIGNMENT**

---

**THIS DEED OF ASSIGNMENT** is made on 25 May 2023 (the “**Assignment**”) **BETWEEN:**

- (1) **EURO GARAGES LIMITED**, a private limited company incorporated in England and Wales with company number 04246195 and whose registered office is at Waterside Head Office, Haslingden Road, Guide, Blackburn, Lancashire, United Kingdom, BB1 2FA (the “**Assignor**”); and
- (2) **EG FINCO LIMITED**, a private limited company incorporated in England and Wales with company number 09826778 and whose registered office is at Waterside Head Office, Haslingden Road, Guide, Blackburn, Lancashire, United Kingdom, BB1 2FA (the “**Assignee**”),

(each a “**Party**” and together the “**Parties**”).

**WHEREAS:**

- (A) The Assignor desires to assign the Transferring IP (as defined below) to the Assignee on the terms set out herein.

**NOW IT IS HEREBY AGREED AS FOLLOWS:**

**1. DEFINITIONS, INTERPRETATION AND EFFECTIVE DATE**

1.1 In this Deed:

“**Domain Names**” means the domain names listed in the Schedule;

“**Effective Date**” means the date of this Assignment;

“**Trade Marks**” means those trade marks, service marks, corporate and trade names, and logos, whether registered or unregistered (and including all registrations or applications in respect of the same) as listed in the Schedule; and

“**Transferring IP**” has the meaning given in Clause 2.

1.2 Unless stated otherwise, references to clauses are to clauses of this Deed.

1.3 References to any Party shall include that Party’s successors and permitted assigns.

1.4 Words importing the singular include the plural and vice versa.

1.5 A reference to “**pounds sterling**” “**£**” is a reference to the lawful currency of the United Kingdom.

1.6 Any words following the terms “including”, “include” or any similar expression shall be interpreted as illustrative and shall not limit the sense of the words preceding those terms.

1.7 This Assignment shall become effective on and from the Effective Date.

**2. ASSIGNMENT**

In consideration of the sum of one pound sterling (£1.00), of which the Assignor acknowledges receipt, the Assignor hereby assigns to the Assignee all of its rights, title, property, and interests in the Trade Marks and Domain Names, together with all rights, privileges, and goodwill solely to the extent subsisting in and relating to the Trade Marks or Domain Names, including, without limitation, the right to bring, oppose, defend or appeal proceedings and recover damages and obtain all other remedies in respect of any infringement or any other cause of action arising from

ownership, of any of the aforementioned intellectual property whether before, on or after the Effective Date (the “**Transferring IP**”).

**3. NO REPRESENTATIONS OR WARRANTIES**

- 3.1 Nothing in this Assignment shall be, or shall be deemed to be, a representation or warranty by the Assignor as to the existence, ownership, validity, enforceability or value of the Transferring IP.
- 3.2 All warranties implied by law (whether by statute or common law or through trade custom or practice or otherwise) are hereby excluded from this Assignment to the maximum extent permitted by law.

**4. FURTHER ASSURANCE AND COSTS**

- 4.1 The Assignor shall, at the written request of the Assignee and at the cost of the Assignee, execute and deliver all such documents and perform such acts as may be reasonably necessary to give full effect to this Assignment, including registration of the Assignee as applicant for, or proprietor of, the relevant Transferring IP.
- 4.2 All third party costs and expenses incurred by either Party relating to the assignment of the Transferring IP (including any cost of recordals) shall be for the account of the Assignee and the Assignee shall upon written request from the Assignor reimburse the Assignor in respect of any such costs it incurs as soon as reasonably practicable. Any such request for reimbursement must be made to the Assignee within 30 days of such costs being incurred by the Assignor.
- 4.3 The Assignor shall, at the request and cost of the Assignee, provide commercially reasonable assistance to the Assignee with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Transferring IP.

**5. INVALIDITY**

If any provision of this Assignment shall be held to be illegal, void, invalid or unenforceable under the laws of any jurisdiction, the legality, validity and enforceability of the remainder of this Assignment in that jurisdiction shall not be affected, and the legality, validity and enforceability of the whole of this Assignment in any other jurisdiction shall not be affected.

**6. WAIVER**

No failure or delay by a Party to exercise any right or remedy provided under this Assignment or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

**7. ENTIRE AGREEMENT**

- 7.1 This Assignment and the documents referred to or incorporated in it constitute the entire agreement between the Parties relating to the subject matter of this Assignment and supersedes and extinguishes any prior drafts, agreements, undertakings, representations, warranties and arrangements of any nature whatsoever, whether or not in writing, between the Parties in relation to the subject matter of this Assignment.
- 7.2 Nothing contained in this Assignment or in any other document referred to or incorporated in it shall be read or construed as excluding any liability or remedy as a result of fraud.

**8. COUNTERPARTS**

- 8.1 This Assignment may be executed in any number of counterparts, and by the Assignor and Assignee on separate counterparts, but shall not be effective until each Party has executed at least one counterpart.
- 8.2 Each counterpart shall constitute an original of this Assignment, but the counterparts shall together constitute one and the same instrument.

**9. THIRD PARTY RIGHTS**

The Parties do not intend that any term of this Assignment should be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person who is not a Party.

**10. GOVERNING LAW**

This Assignment shall be governed by and construed in accordance with English law. Any matter, claim or dispute arising out of or in connection with this Assignment, whether contractual or non-contractual, is to be governed by and determined in accordance with English law.

**11. JURISDICTION**

- 11.1 The courts of England are to have exclusive jurisdiction to settle any dispute, whether contractual or non-contractual, arising out of or in connection with this Assignment. Any proceeding, suit or action arising out of or in connection with this Assignment or the negotiation, existence, validity or enforceability of this Assignment shall be brought only in the courts of England.
- 11.2 Each Party irrevocably submits and agrees to submit to the jurisdiction of the courts of England.
