**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of July 27, 2023, by **U.S. BANK NATIONAL ASSOCIATION**, a United States national association (in such capacity, together with its successors and assigns, “Notes Collateral Agent”) in favor of **R. R. DONNELLEY & SONS COMPANY**, a Delaware corporation with an address at 111 S. Wacker Drive, Chicago, Illinois 60606, **NIES/ARTCRAFT, INC.**, a Missouri corporation an address at 5900 Berthold Avenue, St. Louis, Missouri 63110, **PBM GRAPHICS, INC.**, a North Carolina corporation with an address at 3700 South Miami Boulevard, Durham, North Carolina 27703 and **CONSOLIDATED GRAPHICS, INC.**, a Texas corporation with an address at 5858 Westheimer, Suite 200, Houston, Texas 77057 (each, a “Pledgor” and collectively, the “Pledgors”).

W I T N E S S E T H:

WHEREAS, Pledgors entered into a certain trademark security agreement dated April 28, 2021 (the “Trademark Security Agreement”) with Notes Collateral Agent, notice of which was recorded on April 28, 2021 at the United States Patent and Trademark Office at Reel 7273, Frame 0863.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Pledgors granted the Notes Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Notes Collateral Agent, in all of each such Pledgor’s right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Notes Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Notes Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgors, including all of the goodwill associated with the foregoing, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest and any other liens.
