WHEREAS, under the Purchase Agreement, Assignor and Assignee have agreed to enter in this Agreement to transfer and assign to Assignee all of Assignor's right, title and interest in and to the Trademark Rights.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:
