RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of September 1, 2023 by ALTER DOMUS (US) LLC, in its capacity as the successor administrative agent and collateral agent (in such capacity, the “Collateral Agent”), in favor of BOARDRIDERS IP HOLDINGS, LLC, a California limited liability company, and DC SHOES, INC., a California corporation, (the “Grantors” and each, a “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement, or if not defined therein, in the Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below).

WHEREAS, each Grantor is a party to that certain (i) Term Loan Credit Agreement, dated as of April 6, 2018 (as may have been amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), (ii) Security Agreement, dated as of April 23, 2018 (as may have been amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of DEUTSCHE BANK AG NEW YORK BRANCH, in its capacity as the predecessor administrative agent and collateral agent (in such capacity, the “Original Agent”), and (iii) Trademark Security Agreement, dated as of April 23, 2018, in favor of the Original Agent (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office (“USPTO”) on May 18, 2018 at Reel 6333, Frame 0001, (with respect to Trademarks of Boardriders IP Holdings, LLC), and at Reel 6395, Frame 0697 (with respect to Trademarks of DC Shoes, Inc.), and on November 19, 2018 at Reel 6485, Frame 0413 (with respect to certain additional Trademarks of Boardriders);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor unconditionally granted, collaterally assigned and pledged to the Original Agent a continuing security interest (the “Security Interest”) in the Trademark Collateral, including those marks listed on Schedule I;

WHEREAS, the Original Agent assigned to the Collateral Agent all of the Original Agent’s right, title and interest in, to and under the Trademark Security Agreement, including the Security Interest in the Trademark Collateral, pursuant to that certain Assignment of Intellectual Property Security Agreement, dated as of August 31, 2020, which was recorded with the USPTO on September 1, 2020 at Reel 7041, Frame 0137; and

WHEREAS, each Grantor has requested that the Collateral Agent terminate, release and discharge fully its Security Interest in the Trademark Collateral, and execute a document suitable for recording in the USPTO to evidence the release of the Security Interest in the Trademark Collateral as herein provided.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, hereby releases, terminates, relinquishes and discharges the Security Interest in the Trademark Collateral, and re-assigns to each Grantor any and all right, title or interest it may have in the Trademark Collateral of such Grantor.

The Collateral Agent hereby authorizes each Grantor (and any successor to such Grantor, including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of such Grantor), or any of its or their authorized representatives, to record this Release with the USPTO and/or any other applicable governmental office or agency. The Collateral Agent agrees to execute and deliver to Grantor other instruments and other documents as may be necessary to release the Security Interest in the Trademark Collateral.

THE VALIDITY OF THIS RELEASE, THE CONSTRUCTION, INTERPRETATION, AND ENFORCEMENT HEREOF, AND THE RIGHTS OF THE COLLATERAL AGENT AND THE GRANTORS WITH RESPECT TO ALL MATTERS ARISING HEREUNDER OR RELATED HERETO SHALL BE DETERMINED UNDER, GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
