WHEREAS, pursuant to that certain Second Lien Pledge and Security Agreement, dated as of December 29, 2020 (as may have been amended, restated, amended and restated, modified or supplemented from time to time, the "Security Agreement"), among CPC Acquisition Corp., a Delaware corporation (the "Borrower Representative"), Gardner-Gibson Acquisition Corp., a Delaware corporation (the "GGI Borrower" and, together with the Borrower Representative, each, a "Borrower" and collectively, the "Borrowers"), ICP Group Holdings, LLC, a Delaware limited liability company ("Holdings"), and each of the other parties thereto, whether as an original signatory thereto or as an Additional Grantor (as defined in the Security Agreement) (together with the Borrowers and Holdings, each, a "Grantor", and collectively the "Grantors") in favor of the Successor Collateral Agent (as successor to the Resigning Collateral Agent) for the Secured Parties (as defined in the Security Agreement) (i) a Second Lien Patent Security Agreement, dated December 29, 2020, which was recorded in the United States Patent and Trademark Office ("USPTO") on January 4, 2021 at Reel/Frame 054888/0048, (ii) a Second Lien Trademark Security Agreement, dated December 29, 2020, which was recorded in the USPTO on January 4, 2021 at Reel/Frame 7149/0626 and (iii) a Second Lien Copyright Security Agreement, dated December 29, 2020, which was recorded in the United States Copyright Office on January 5, 2021 at Vol. 9986, Doc. No. 098 (each, an "IP Security Agreement" and collectively, the "IP Security Agreements");

WHEREAS, pursuant to the Security Agreement and the IP Security Agreements, each Grantor pledged and granted to the Resigning Collateral Agent for the benefit of the Secured Parties a lien on and security interest in (the "Security Interest") all of its right, title and interest in, to and under the Collateral (as defined in each of the IP Security Agreements), including the Patents listed on Schedule I hereto, the Trademarks listed on Schedule II hereto, and the Copyrights listed on Schedule III hereto (collectively, the "IP Collateral");

WHEREAS, pursuant to that certain Agency Transfer Agreement, dated as of September 15, 2023, the Resigning Collateral Agent resigned as collateral agent under the Loan Documents (as defined in the Credit Agreement (as defined in the Security Agreement)) and was succeeded by the Successor Collateral Agent, and in furtherance thereof the Resigning Collateral Agent assigned to the Successor Collateral Agent, and the Successor Collateral Agent assumed, the Security Interest in the IP Collateral.

WHEREAS, the Resigning Collateral Agent and the Successor Collateral Agent desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the USPTO and USCO;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Resigning Collateral Agent hereby assigns to the Successor Collateral Agent, and the Successor Collateral Agent hereby assumes, all of the Resigning Collateral Agent's right, title and interest in, to and under, the IP Collateral and each IP Security Agreement, including, without limitation, its Security

Interest in each Grantor's right, title and interest in, to and under the IP Collateral. The foregoing assignment is made without representations or warranties of any kind.

This Agreement may be executed in one or more counterparts (and by different parties hereto in different counterparts), each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Delivery by telecopier or other electronic transmission of an executed counterpart of a signature page to this Agreement shall be effective as delivery of an original executed counterpart of this Agreement. The Successor Collateral Agent may also require that signatures to this Agreement delivered by telecopier or other electronic transmission be confirmed by a manually-signed original thereof; provided that the failure to request or deliver the same shall not limit the effectiveness of any document or signature delivered by telecopier or other electronic transmission. The words "execution," "signed," "signature," and words of like import in this Agreement shall be deemed to include electronic signatures or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable Law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.

This Agreement shall be governed by, and construed in accordance with, the law of the state of New York. Sections 10.15(b), 10.15(c), 10.15(d) and 10.16 of the Credit Agreement are hereby incorporated by reference into this agreement and shall apply hereto.
