**TERMINATION OF TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT, dated as of October 30, 2023 (this “Release”, is made by ALLY BANK, in its capacity as agent for itself and the other lenders (together with its successors and assigns in such capacity, “Agent”) in favor of Enovate Medical, LLC, a Delaware limited liability company (the “Grantor”).

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated as of April 20, 2020, by Grantor in favor of Agent (the “Trademark Security Agreement”), Grantor granted to Agent, as successor in interest to Fifth Third Bank, a security interest in all right, title and interest of Grantor in and to certain intellectual property, including the trademark registrations and applications set forth in Schedule A (the “Trademark Collateral”); and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on April 20, 2020 at Reel 6919 Frame 0110; and

**WHEREAS**, Grantor requests a specific release of the security interest granted and recorded against the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Secured Parties (as defined in the Trademark Security Agreement), (i) releases any and all liens, security interests, right, title and interest the Agent or any Secured Party may have in, to or under the Trademark Collateral, and (ii) hereby authorizes the Grantor or the Grantor’s authorized representative or designee to record this Release with the USPTO as evidence of such release and termination

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
