- 2. Goodwill. Such conveyances shall include all goodwill appurtenant to the Trademark Rights.

interest in and to any and all claims and demands Assignor may have either at law or in equity arising out of past, present or future infringement of the Trademark Rights.

- 6. <u>RECITALS</u>. The recitals and definitions set forth in the "Whereas" recitals above are incorporated herein word for word and made a part of this Assignment for all purposes.


