COMMISSIONER FOR TRADEMARKS:

Applicant LIVSMED Inc. is a Republic of Korea corporation whose address is 304, D-dong, 700, Pangyo-ro, Bundang-gu, Seongnam-si, Gyeonggi-do, 13516, Republic of Korea.

Applicant requests that the mark shown in the accompanying drawing be registered in the United States Patent and Trademark Office on the Principal Register established by the Act of July 5, 1946, as amended, as to goods as follows:

LAPAROSCOPES; MEDICAL DEVICES USED IN LAPAROSCOPIC SURGERY; MEDICAL ROBOTS USED IN LAPAROSCOPIC SURGERY; MEDICAL AND SURGICAL LAPAROSCOPES AND CATHETERS; ENDOSCOPES; SURGICAL INSTRUMENTS AND APPARATUS; THORACOSCOPES; MEDICAL CAMERAS; SURGICAL CLIPS; ELECTRIC CAUTERIES FOR SURGICAL USE; STAPLERS FOR MEDICAL PURPOSES; MEDICAL SUTURING DEVICES; ELECTRIC CAUTERIES; TROCARS; DISPOSABLE MEDICAL FORCEPS; FORCEPS; ELECTRODES FOR MEDICAL USE; LASER OPERATING MACHINES; LASERS FOR SURGICAL AND MEDICAL USE; LASERS FOR MEDICAL PURPOSES; ARTICULATING LAPAROSCOPIC INSTRUMENTS; SURGICAL APPARATUS AND INSTRUMENTS FOR USE IN MINIMALLY INVASIVE SURGERY; SURGICAL INSTRUMENTS, NAMELY, END-EFFECTUATORS, BIPOLAR FORCEPS, NEEDLE HOLDERS, CLIP APPLIERS, MONOPOLAR HOOKS, BIPOLAR DISSECTORS AND MONOPOLAR SCISSORS in Class 10.

The literal element of the mark is LIVSMED.

The mark consists of the stylized term LIVSMED in blue to the right of a geometric design with a light green upper portion and a light blue lower portion.

The colors blue, light green and light blue are claimed as a feature of the mark.

CLAIM UNDER SECTION 1(b)

Applicant has a bona fide intention to use the mark in commerce on or in connection with the above-identified goods under Section 1(b) of the Act (15 U.S.C. 1051(b)), as amended.

CLAIM UNDER SECTION 44(d)

Applicant has a bona fide intention to use the mark in commerce on or in connection with the above-identified goods and asserts a claim of priority based on a foreign application in accordance with Section 44(d) of the Act (15 U.S.C. 1126(d)), as amended. The claim of priority is based on Republic of Korea Application No. 40-2019-0132929, filed August 26, 2019. A copy of the corresponding registration and a signed translation will be submitted upon its issuance.


DECLARATION
