Application to register said mark in the European Union was filed on July 4, 2019 under Application No. 018091551. Applicant requests that said mark be registered in the United States Patent and Trademark Office on the Principal Register established by the Act of July 5, 1946.

The mark consists of vertically non-Latin characters. To the right of this is a dividing line that, for its first and fourth quarters, is colored yellow with red and yellow stripes at either end. In between, the dividing line is colored red. To the right of this is the wording MONKIE in a stylized yellow font, followed by KID in a stylized red font with a yellow dot of the letter "i". Each letter is rotated 90 degrees to have its base facing left. Between the two wordings is a stylized illustration of a monkey's face outlined in yellow, with black fur on its forehead, yellow eyebrows, white outline of its face below its eyebrows, black eyes signified by upward-pointing arches, black triangle nose, and a wide band of white teeth. On either end of the row of teeth is a red ear.

The non-Latin characters transliterate to Wu Kong Xiao Xia and translate to Monkie Kid.
