The mark contains three concentric circles. Each circle consists of a series of 20 unconnected rectangles, with each rectangle starting at a point that is near the middle of the rectangle to its right, and extending outward from that point at an angle that is to the left of the rectangle to its right. The rectangles in the middle circle are smaller than the rectangles in the outermost circle, and the rectangles in the innermost circle are smaller than the rectangles in the middle circle. Beneath the three concentric circles, the words THRILL ONE appear. Beneath the words THRILL ONE, the words SPORTS & ENTERTAINMENT appear in smaller letters.

Color is not claimed as a feature of the mark.
