REMARKS

With respect to the services based upon Section 44(e) in Class 43, Applicant has now submitted a copy of its foreign registration certificate and the appropriate document confirming its renewal. In this regard, Applicant notes that although the Certificate of Singapore Registration No. T9506172D shows that it was registered in the name of RAFFLES HOTEL (1886) LIMITED, it was subsequently acquired by Applicant on March 1, 2008. A copy of the Certificate of Subsequent Proprietor is attached herewith (see *Exhibit A*).

Further, Applicant notes that due to PTO errors, the identification of services in Classes 36 and 43 do not show the correct filing bases. Applicant respectfully requests that the record be corrected to reflect the correct filing bases identified in the executed application form provided at the time of filing. In this regard, the identification of services should be corrected to read as follows (note the filing bases as well as the dates of first use, where appropriate):

Class 36: (Based on Section 1(b)) Real estate affairs; real estate management; real estate administration; management of apartments or villas; apartments, buildings and residential properties management services; buildings management (real estate services); apartment house management; financial and real estate management of apartments and accommodation, such as hotels, motels, hotel complexes, apartments, residential hotels, tourist homes and other residential buildings for holiday homes and holiday camps; sale and rental of accommodations, apartments, studios, rooms inside hotel establishments, hotel complexes, residential hotels and other residential buildings for holiday homes and holiday camps; rental and management of accommodation for others; rental of real estatebased timeshare; management and rental services of real estate time-sharing; assistance and consultancy services in the field of real estate; management and operation of branded residences; management and operation of extended stay serviced apartments and villas; rental of apartments; rental and provision of offices, office space and work areas for collective or individual use; rental and provision of common work areas or work areas to be shared; rental of furnished offices; business and project financing services

<u>Class 43</u>: (Based on use under Section 1(a) – *Dates of First Use: April 2012*) Reservation services for hotel accommodation; making reservations and bookings for temporary lodgings; making reservations for long and short term stays in apartments and condominiums; bookings for restaurants; information on hotels, resorts, accommodations and restaurants, provided by an online searchable computer database; providing a website featuring online reservation services for hotel accommodation; making hotel reservations and bookings for temporary lodging and accommodations; making hotel reservations for others; making reservations and bookings for others for accommodations at hotels; information, advisory and consulting services relating to all the aforesaid services; including all the aforesaid services provided electronically or online from a computer data base or via the internet;

(**Based on intent-to-use under Section 1(b)**) Services for providing food and drink; temporary accommodation; resort services; bookings for meals, banquet and social function facilities for special occasions; providing of facilities for conventions and exhibitions; childcare services (crèches); information, advisory and consulting services relating to all the aforesaid services; including all the aforesaid services provided electronically or online from a computer data base or via the internet;

(**Based on a foreign registration under Section 44(e)**) Hotel services; hotel accommodation services; room hire; provision for conference facilities, banqueting services; bar, café, restaurant services, cocktail lounge and coffee shop services, food cooking services
