Aquatrols Corporation of America, a corporation duly organized under the laws of the State of Delaware, having its principal place of business at 1273 Imperial Way, Paulsboro, New Jersey 08066, requests that the mark shown in the accompanying drawing be registered in the United States Patent and Trademark Office on the Principal Register established by the Act of July 5, 1946 for the following goods: chemicals, namely soil conditioners for use in promoting water movement in soil in Int'l Class 001.

The undersigned, Tracy M. The mark consist of black lower case letters, except for the letter "u" which is formed by a light blue water drop design, gradient-filled and surrounded by a drop shadow. Behind the water drop design are three layered water drops of progressively deepening blue colors stepped downward with each being solid-filled and individually surrounded by a drop shadow.
