The mark has been registered in respect of:

Class 03:

Perfumes, perfumery, toiletries and cosmetics; soaps, liquid soap, shower gels, bath gels, shower foams and bath foams; fragrances, toilet water, eau de cologne and essential oils; hair creams, hair gels, hair wax, hair serum, hair shampoo, hair lotions, hair conditioner and hair care preparations; bath salts and bath oils; preparations and additives for bath and shower use; creams, lotions, milks, oils, powders and ointments for the care and the cleansing of the skin, body, hands and feet; face packs, mud packs and face masks; deodorants and anti-perspirants; talcum powder; dentifrices, mouth washes and breath fresheners; towels and tissues impregnated with any of the aforesaid goods.

Class 08:

Cutlery; hand tools and instruments; scissors, clippers and trimmers; parts and fitting for all the aforesaid goods; but not including saws.

Class 09:

Sunglasses, spectacles, spectacle frames and fitted cases for spectacles and sunglasses; parts and fittings for all the aforesaid goods.

Class 14:

Precious metals and their alloys and goods in precious metals and their alloys or coated therewith; jewels and jewellery; paste, imitation, fashion, artificial and costume jewels and jewellery; precious and semi-precious stones; decorative articles for personal use; horological and chronometric instruments; parts and fitting for all the aforesaid goods.

Class 18:

Leather and imitations of leather; goods made from leather and imitations of leather; trunks, cases and bags; travelling bags, handbags and sports bags; purses, wallets and jewellery cases; umbrellas, parasols and walking sticks; parts and fittings for all the aforesaid goods.



Class 21:

Household, kitchen and domestic utensils and containers; combs, sponges and brushes; kitchen towels and impregnated towels; towel and tissue holders and dispensers; crockery and china; glass, glassware, porcelain and earthenware; vases, planters and bowls; parts and fittings for all the aforesaid goods.

Class 24:

Textiles and textile goods; bedding, linen and wall hangings; curtains; bed and table covers; napkins, towels and flannels; tea towels; parts and fitting for all the aforesaid goods.

Class 25:

Articles of clothing; articles of outer clothing; articles of underclothing; footwear; headgear; legwear; belts.

Class 29:

Meat, fish, poultry and game; meat extracts; preserve, dried and cooked foods and vegetables; jellies, jams, fruit sources; eggs, milk and milk products; edible oils and fats; marmalades and preserves; pickles, chutneys and olives; milk beverages.
