

Statement Under 37 C.F.R. §2.42(b) and Geographic Restriction of Service Mark

To the Commissioner for Trademarks:

Zachary Konell, on behalf of Bulldog Cleaning & Restoration LLC ("Applicant"), provides the following information in support of the service mark application for the word mark BULLDOG ("Mark").

- 1) Applicant is using the Mark in commerce in the greater Philadelphia area, including portions of New Jersey and Delaware.
- 2) Applicant is using the Mark in connection with at least the following services:

Class 37: Building construction; repair; installation services.

Property damage restoration services, consisting of, restoring building exteriors, interiors, flooring, drapery, furnishings, and contents, damaged by fire, smoke, water, flood, storm, snow, ice, or other natural or human causes; property damage mitigation and remediation services, consisting of, physical clean-up and repair of buildings and building contents to restore them to their pre-loss condition; building repair and reconstruction services; building construction services; carpentry services; painting services; building maintenance services; carpet repair and installation services; air duct and dryer vent cleaning services; janitorial and cleaning services; floor, carpet, rug, drapery and upholstery cleaning services; dry cleaning.

Class 40: Treatment of materials

Mold remediation services; mold sampling and testing; mold prevention treatment of building exteriors, interiors, carpet, rugs and furnishings; property damage mitigation services, consisting of, odor removal services for air, carpet, rugs, and drapery, and deodorization services for buildings and their contents; indoor air quality sampling and testing; water quality sampling and testing; lead abatement; sampling and testing for allergens, legionella, asbestos, and lead.

- 3) There is no mode of use restriction for which Applicant seeks registration.
- 4) Potential concurrent users are as follows:

- 6) The concurrent users may be using marks confusingly similar to the Mark on or near their places of business.
- 7) The concurrent users may be using their marks for the following services:

Bulldog Restoration: Water damage mitigation, including damage from broken pipes and storm damage. Mold remediation. Carpet cleaning.

Bulldog Water Restoration: Water damage mitigation, including damage from natural disasters, broken pipes, damaged roofs, and broken hoses. Mitigation from fire and smoke damage. Mold removal. Removal of smoke odor.
- 8) There may be no mode of use restriction for the services of the concurrent users.
- 9) I do not know when the concurrent users may have begun providing services in connection with a mark confusingly similar to the Mark.
- 10) Applicant is willing to restrict the geographic scope of the Mark to the entire United States except as stated below:

Applicant is willing to restrict the geographic scope of the Mark to the entire United States except for a fifty mile radius around 6210 Trevor Way, Young Harris, GA 30582, only with respect to the excepted user Bulldog Restoration located at 6210 Trevor Way, Young Harris, GA 30582. The restriction is limited to any service which Bulldog Restoration currently provides which is also listed in connection with the Mark.

Applicant is willing to restrict the geographic scope of the Mark to the entire United States except for a fifty mile radius around 2455 Hollywood Blvd., #314, Hollywood, FL 33020, only with respect to the excepted user Bulldog Water Restoration located at 2455 Hollywood Blvd., #314, Hollywood, FL 33020. The restriction is limited to any service which Bulldog Water Restoration currently provides which is also listed in connection with the Mark.

To the best of my knowledge, information, and belief, any factual statements above are true.
