Organize

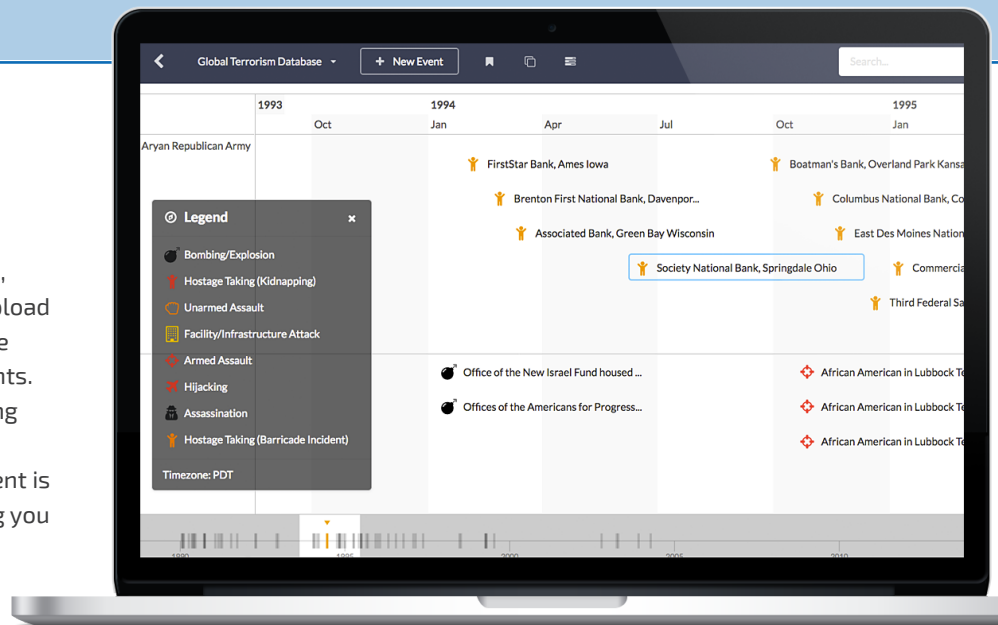

All data connected to a selected event is viewable alongside the timeline, allowing you to visualize and dynamically reflect on every piece of evidence.

Visualize

Group your events into layers to **easily analyze intertwining storylines.** Track events over vast periods of time, or right down to a precise moment. View the events on a map, and see how the story geospatially unfolds over time. Filter out unnecessary evidence so you can pinpoint the actors and events of interest.

Communicate

Timestream allows you to instantly communicate your case information. Multiple agents can **collaborate in real-time** to build the digital case file. All files are forensically hashed, keeping the digital chain of custody intact. **Create a comprehensive report** of your data or instantly generate compelling presentation slides and interactive maps straight from your evidence. Whether you provide your team with a read-only link to the timeline, or use Timestream's export to PowerPoint feature, distributing and presenting your evidence is made easy and efficient.

Flexible Ingestion

Timestream's flexible ingestion allows investigators to import files, notes, social media, and publicly available information directly into their timeline. Manually drag and drop files into your case, or import a spreadsheet of events through our robust APIs. From there, categorizing your evidence is easy, and the data deconflicts as you go.

Interactive Map

View events on the interactive map for geospatial context, and demonstrate how a story progresses over time.



Tags and Layers

Identify events of interest by filtering your timeline to a specific tag, or segment it into several timelines to simultaneously analyze multiple threads of a story.



Search

Search all evidence, annotations, and case data in one powerful search query.



Forensic Hashing

Validate the authenticity of your evidence with the forensic hash automatically calculated by Timestream.

Powerful Timeline Visualization

The core of Timestream is a powerful and flexible timeline visualization engine that brings clarity to a complex sequence of events. It allows you to view events across several years, or narrowed down to the second. Timestream's expansive color-coded icon library helps you visualize the different event categories at a glance.

Presentations

Timestream automatically assembles the information you've collected on a particular event into a "smart slide," which embeds images, links, geospatial data, and your commentary. Slide content automatically updates as you make changes to your timeline. You can also include snapshots of the timeline or map views to add temporal or geospatial context. It is easy to create and manage multiple presentations for different audiences from within the same case file.

Timestream integrates with Ntrepid's misattributed evidence collection platform, Nfusion, to provide a seamless pipeline between collection and building a digital case file. We offer flexible deployment options with Timestream, including cloud or on-premise deployment.

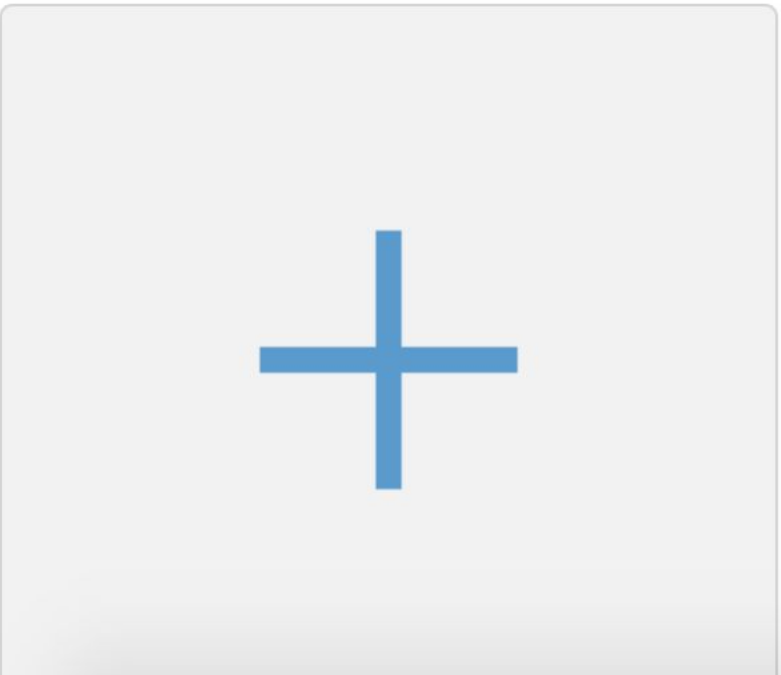
