CERTIFICATE OF IDENTITY OF MARK

Code of Intellectual Property - Book VII

Art. L. 712-1. - Ownership of the mark is acquired by registration. The mark may be acquired in joint ownership. Registration become effective as of the date of filing the application for a period of ten years, renewable indefinitely.

Art. R. 714-2. - The national register of marks is kept by the National Institute of Intellectual Property. There appears for each mark:

1. Identification of the applicant and filing data, as well as subsequent acts affecting its existence or scope.
2. Acts modifying the ownership of the mark or the enjoyment of the rights associated with it; in case of a claim of ownership, the corresponding assignment;
3. Changes of name, of legal form or of address as well as corrections of material errors affecting the entries.

No entry is inscribed in the register until the application is published under the conditions prescribed in Article R.712-8.

Art.R.714-8. Each entry inscribed in the national register of marks shall be published in the Official Bulletin of Intellectual Property.

Any interested person may obtain from the institute:

1. A certificate of identity comprising the model (representation) of the mark, data relating to the filing and registration, and, if applicable, any limitations of the list of goods or services resulting from a withdrawal, a surrender or a judicial decision
2. A reproduction of the entries made in the national register of marks;
3. A certificate that there is no entry.

The general director of the national institute of intellectual property certifies that the mark reproduced on the obverse side was registered and published in the Official Bulletin of Intellectual Property.

He certifies in addition that it appears from the national register of marks that:

The mark is not subject to any limitation of the list of goods or services resulting from a withdrawal, surrender or judicial decision,

The mark has been the object of any limitation of the listed goods or services resulting from a withdrawal, surrender or judicial action, and reproduced in the attachment to this certificate

The mark has been the object of a decision bearing totally or partially on the registration (attached to this certificate)

The mark has been the object of declaration(s) of renewal reproduced in the attachment to this certificate

The mark has not been the object of any declaration of renewal.
