A. INTENT-TO-USE BASIS

The above-identified applicant has a bona fide intention to use the above mark in commerce on or in connection with the following goods, and requests that said mark be registered in the United States Patent and Trademark Office on the Principal Register established by the Act of July 5, 1946 under Section 1(b):

- Class 9:** Glass panels and screens as window component parts for laser installations and industrial equipment use; worked glass, not for building; optical glass; glass for use in optical lenses; worked sapphire glass, not for building; optical sapphire glass; sapphire glass for use in optical filters and optical lenses
- Class 19:** Building glass; window glass for building; window sheets and glass panels; sapphire glass for building; sheets made of glass for building or construction materials; sheets made of sapphire glass for building or construction materials; non-metallic building materials
- Class 21:** Unworked or semi-worked glass, not for building; unworked or semi-worked glass, except building glass, unworked or semi-worked sapphire glass, not for building

B. FOREIGN REGISTRATION BASIS and PRIORITY CLAIM

Application to register said mark in Japan filed on November 22, 2018 under Application No. 2018-144953 remains pending. Applicant asserts a claim of priority based upon this application in accordance with Section 44(d). Applicant intends to rely on Section 44(e) as a basis for registration and requests that the application be suspended to await submission of the foreign registration. If ultimately the applicant does not rely on §44(e) as a basis for registration, a valid claim of priority may be retained.


