Miscellaneous Statement: Under the 2018 Farm Bill (Agriculture Improvement Act of 2018), which passed earlier this year, the definition of “marihuana” in the Controlled Substances Act was amended to remove “hemp,” as defined in section 297A of the Agricultural Marketing Act of 1946. The definition of “hemp,” as amended by the Farm Bill, is “the plant *Cannabis sativa* L. and any part . . . [THC] concentration of not more than 0.3 percent on a dry weight basis.” The products subject to the application are not controlled substances because they will not contain more than 0.3 percent THC.
