The mark comprises the words "Acorn" and BASyC above the word "Controls", wherein the letter "T" extends above and over the letters "N" and "R" and two horizontal lines extend on either side of the letter "T" above the word "Controls". Below the word "CONTROLS" appears the depiction of a series of concentric curved lines.

The mark appears in the colors black, white, and gray to represent shading; but color is not claimed as a feature of the mark.

Applicant is the owner of Reg. No. 4585959 and 4660601, and others.
