

right to bring any suit, action, or proceeding against you for breach of the Agreement in your country of residence or any other relevant court. You hereby waive any and all objections to exercise of jurisdiction over you by such courts and to venue in such courts.

### 17. Arbitration and Class Action Waiver

At Company's sole discretion, it may require you to submit any disputes arising from the Agreement, including disputes arising from or concerning interpretation, violation, invalidity, non-performance, or termination, to final and binding arbitration under the Rules of Arbitration of the American Arbitration Association applying California law. Where permitted under applicable law, you agree that you may bring claims against the Company in your individual capacity and not as a plaintiff or class member in any purported class or representative action.

### 18. Complete Agreement and Severability

The Agreement is the entire agreement between you and the Company regarding the Service and/or Digital Content, and supersedes all prior understandings regarding such subject matter. If any term or condition of this Agreement is deemed invalid, void, or for any reason unenforceable, that part will be deemed severable and will not affect the validity and enforceability of any remaining term or condition.

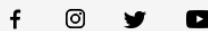
