International Class 8: *hair cutting scissors; electric hair straightening irons; electric hair curling irons; electric irons for styling hair; bags and cases specially adapted for holding or carrying electric hair curling irons; razors; razor blades; hair clippers; hair trimmers; hair-removing tweezers; blades and brushes for electric hair clippers and trimmers; hair crimpers*
