

The mark was first used anywhere for the goods in Class 14 at least as early as October 27, 2011 and was first used in U.S. commerce at least as early as October 27, 2011.

The mark was first used anywhere for the goods in Class 16 at least as early as January 2010 and was first used in U.S. commerce at least as early as January 2010.

The mark was first used anywhere for the goods in Class 18 at least as early as December 1, 2014 and was first used in U.S. commerce at least as early as December 1, 2014.

The mark was first used anywhere for the goods in Class 21 at least as early as July 4, 2017 and was first used in U.S. commerce at least as early as July 4, 2017.

The mark was first used anywhere for the goods in Class 25 at least as early as January 2016 and was first used in U.S. commerce at least as early as January 2016

The mark was first used anywhere for the services in Class 28 at least as early as January 2020 and was first used in U.S. commerce at least as early as January 2020.

The mark was first used anywhere for the services in Class 41 at least as early as March 2011 and was first used in U.S. commerce at least as early as March 2011.

Specimens showing the mark as used in commerce on or in connection with the goods and services are presented herewith.

The mark consists of the wording "CITY" in a stylized font. The letter "C' is formed by a rotated crescent. The letter "I" is formed by a black bar separating a square and a rectangle. The letters "T" and "Y" are formed by a rectangle and an irregular hexagon, below a trapezoid and a parallelogram, all of which are separated by black bars.

No color is claimed as a feature of the mark.
