Preliminary Amendment

The purpose of this Preliminary Amendment is to clarify and explain certain complexities with the submitted Certified Copy of the corresponding Russian Registration and the applicant's name as shown on the Russian Certified Copy.

Certified Copy

The Examining Attorney is advised that the Certified Copy of the Russian Registration which is attached as part of the application is presented in black and white while the applied for mark is in color.

The undersigned US attorney has been advised by Russian Counsel that the Russian Patent
Office does not issue certified copies in color but only in black and white. The Examining
Attorney's attention is directed to the color description of the mark, which is part of the certified translation of the certificate. The applicant's Russian Attorney is attempting to obtain a color copy from the Russian Patent Office.

Name of the applicant

The name of the applicant in the US application is - Joint Stock Company "Russian Copper Company", the name listed on the Russian Certified Copy is - Closed Joint Stock Company "Russian Copper Company". The applicant Joint Stock Company "Russian Copper Company" and Closed Joint Stock Company "Russian Copper Company" are the same entity, the applicant name change was the result of a change in Russian law. The US application is submitted in the name of Joint Stock Company "Russian Copper Company", which is the legal name of the applicant under Russian law and as required by the Russian Patent Office.

The Russian registrant did not submit any documents to the Russian Patent Office to make changes to their name in the trademark register because such was not required by law but was a change made pro forma by the Russian Patent Office. This change was made in connection an "Information Letter" from the Patent office and as required by Russian law.

The following is a translation of the "Information Letter" sent by the Russian Patent Office:

"On additional explanations on the issue of making changes related to changing the name of a legal entity in terms of specifying its organizational and legal form, in the materials of applications and registers of registered intellectual property objects in connection with changes to part one of the Civil code of the Russian Federation"

In addition to the information letter of the Federal service for intellectual property (further – Rospatent) from 26.01.2015 No. 1 "On introducing amendments related to changing the name of the legal person in terms of specifying its legal form, in material applications and registers of the registered objects of intellectual property in connection with changes to the Civil code of the Russian Federation" Rospatent with the received appeals on this issue and in consultation with the Ministry of economic development of the Russian Federation informs the following.

In case of change of name of a legal person in terms of specifying its legal form, associated with bringing it into conformity with the provisions of the Civil code of the Russian Federation (further − GK the Russian Federation) as amended by Federal law dated 05.05.2014 № 99-FZ "On amendments to Chapter 4 of the Civil code of the Russian Federation and on invalidating certain provisions of legislative acts of the Russian Federation" (hereinafter − Federal law No. 99-FZ), the provisions of the second paragraph of paragraph 1 of article 1232 of the civil code of the Russian Federation must be applied in accordance with the provisions of Federal law No. 99-FZ. This circumstance implies, in particular, that making appropriate changes to the registers of registered intellectual property objects (hereinafter referred to as Registers), security documents (patents and certificates) and applications containing the former name of the legal entity is not mandatory.

Identified in the provision of the rendered state services in the sphere of legal protection of results of intellectual activity and means of individualization of a mismatch indication of the legal form of the legal entity in the applicant's documents to the data from the respective Registers does not preclude the provision of public services in case of change of name of the legal entity in accordance with the Federal law № 99-FZ.

It should also be noted that the modification of the Registers, documents and applications, including those associated with bringing the legal form into line with the provisions of the civil code in the wording of Federal law No. 99-FZ, is the option of the holders (the applicants), on the basis of their applications and upon payment of the appropriate fee.

В дополнение к информационному письму Федеральной службы по интеллектуальной собственности (далее - Роспатент) от 26.01.2015 № 1 «О внесении изменений. связанных с изменением наименования юридического лица в части указания его организационно-правовой формы, в материалы заявок и реестры зарегистрированных объектов интеллектуальной собственности в связи с изменениями в часть первую Гражданского кодекса Российской Федерации» Роспатент с учетом поступивших обращений по данному вопросу и по результатам консультаций с Министерством экономического развития Российской Федерации сообщает следующее.

В случае изменения наименования юридического лица в части указания его организационноправовой формы, связанного с приведением его в соответствие с положениями Гражданского кодекса Российской Федерации (далее – ГК РФ) в редакции Федерального закона от 05.05.2014 № 99-ФЗ «О внесении изменений в главу 4 части первой Гражданского кодекса Российской Федерации и о признании утратившими силу отдельных положений законодательных актов Российской Федерации» (далее – Федеральный закон № 99-ФЗ), положения абзаца второго пункта 1 статьи 1232 ГК РФ должны применяться с учетом положений Федерального закона № 99-ФЗ. Данное обстоятельство подразумевает, в частности, что внесение соответствующих изменений в реестры зарегистрированных объектов интеллектуальной собственности (далее -Реестры), охранные документы (патенты и свидетельства) и заявки, содержащие прежнее наименование юридического лица, не является обязательным.

Выявленное при предоставлении Роспатентом государственных услуг в сфере правовой охраны результатов интеллектуальной деятельности и средств индивидуализации несоответствие указания организационно-правовой формы юридического лица в представленных заявителем документах сведениям соответствующих Реестров не является препятствием для предоставления государственной услуги в случае изменения наименования юридического лица в соответствии с Федеральным законом № 99-ФЗ.

Одновременно необходимо отметить, что внесение изменений в Реестры, охранные документы и заявки, в том числе связанных с приведением организационно-правовой формы в соответствие с положениями ГК РФ в редакции Федерального закона № 99-ФЗ, осуществляется по желанию правообладателей (заявителей), на основании их заявлений и при условии уплаты соответствующей пошлины.
